Scott was on a set directing a scene when he received a phone call. It was at a bowling alley. It was Jerry Matthews. Scott held up the filming while he's speaking on the phone.

Scott: "Hello! This is Scott?"

Jerry: "Hi, Scott! This is Jerry Matthews of the Washington political society; I major in economics for the economy. I was informed by Tony Percheatty about you and your new world order you have come up with. I've read your book, and I think it's very good. The new world order you speak of in the book is mind-boggling to me. At first when I looked at it, I was saying it wouldn't work giving everyone money due to the fact that the dollar would lose its value and cause inflation. But after studying it and watching a few of your videos on your website, I have come to the conclusion that it's a very good amazing idea you have come up with."

Scott: "Thanks, Jerry! I've been expecting your call! I've been thinking about it for a long time to make a better economic policy for the world."

Jerry: "Scott, do you have time to talk now? You mind if I ask you a few questions about your policy and your new world order plan? That is to make up and give out an unlimited amount of money for the United States Government and the rest of the world to be as one identity."

Scott: "Not really. I'm filming for a movie right at the moment. But I suppose I could stop everything for a few minutes to talk."

Scott told everyone on the set to take a thirty-minute break.

Jerry: "The first thing I would like to clear up is how would you control the fluctuation of the dollar in the economy?"

Scott: "There would be a tariff placed on all food products, rental of homes, apartments, utilities, insurance, and new cars to where they can't increase more than 10% a year. For instance, if there's a loaf of bread that sells for \$2 during the year from calendar date of January 1st to December 31st, no more than \$0.20 can be added to the loaf to equal \$2.20 for that calendar year. Only after the following year the cost-of-living allowance fluctuation will be figured in for each district or county. The housing, new autos, utilities, insurances, and food then again may fluctuate only 10% for the following fiscal year. Some items may be decreased or increased on price depending on demand or shortages. Businesses and companies will be fined greatly if they're not within compliance, which is dictated by the district, county, or within the government. After time, the economy will be at a steady common rate."

Jerry: "How much will each person get per month or year, and how is it broken down? I found it to sound complicated to understand all the details when I watched your video."

Scott: "See, I used an example of Monticello, Iowa, as being a small community. I based the costs of living to be approximately \$20,000 a year for a single person to live off of. If there is a couple, each person will get \$20,000 to equal \$40,000 a year! For a single person, that would be about \$1,666 a month. You would take the cost of average living expenses per district or county that is set up for the world policy. I'll use Monticello to explain for an example of the breakdown. For instance, if you were to rent or make payments on a cheap one-bedroom house, it would cost \$500 on average. With insurance, \$75; natural gas, \$50; electric, \$75; water and sewer, \$66; used or new car payment, \$250; miscellaneous, \$50; and food, \$600, this is without having a job. If you choose to work, your benefits will stay the same for entitlement.

Each person is entitled to claim one kid to receive an extra \$500 a month until they're eighteen years old to spend as they wish. So, a couple with two kids would receive \$51,984 a year. No extra money is given beyond one child per person. But let's say one of the couples in the relationship that has two kids chooses not to take custody and leaves the child with the mother or the father to care for, \$500 for the one kid would be received, and if the other spouse chooses not to take care of the child, the one with the two children would receive \$1,000 for the kids. If a child, woman under 18 years of age has a baby. From the time the baby is born that individual will be entitled to receive the Cost-of-Living Allowance given through the government. There will be no more alimony for the children from the opposite parent to collect for two kids. If the opposite parent decides to work and that parent is making extra money, the government will allow the courts to demand the alimony up to 25% of the parents' working wages, if he or she chooses not to care for the child or children. Usually, it'll work in cases with parents that have more than three kids together to receive the full 25% of the wages working or \$500 dollars to be granted."

Jerry: "That sounds pretty good. Sounds like you got it figured out, but what about state government aid for the people, like food stamps, unemployment, money for assisted housing, WIC, and other government programs?"

Scott: "There will be no other government programs assisting the people, besides what would be of the cost-of-living allowance that is given for the new world policy. Food stamps would be done away with. Unemployment will be done away with also. But Social Security, if you paid into it through a job, you will still have that as a backup for retirement or disability on top of the cost-of-living allowance. It'll be determined on the amount that you pay in for the amount you receive for retirement or disability from the day when the new world policy takes effect.

If you never work, you'll never get Social Security, and if you choose to work part-time or very little, very little will come back to you from Social Security. Other pensions from the government that the people have worked over the years will only be authorized to the individuals prior to the new world

policy date. They will be discontinued in the future.

If they have ten or more years working for the government's policy, it will be prorated for the time they served, for the ten years or more, but will not continue any further in the future for said policy. This will only be paid out as dictated by the old standing policy of country or government. If they are disabled and received a policy, they will receive it until they are in the grave."

Jerry: "That's all good to know! You have made it very clear to me. Thanks, Scott, for your time."

Scott: "Okay, here it goes! I named it Ace Services with three branches: Ace of Hearts, Ace of Spades, and Ace of Diamonds. It stands for American Constitution of Economics."

Sondra: "Interesting! What do the ACE'S stand for?"

Scott: "The Ace of Hearts stands for love and represents the people for healthcare and anything related. The A, standing for America and the definition for America, is relating to the United States or to the continents of America. The Ace of Spades stands for power and represents the leadership, justice for all the people alike. The C, standing for Constitution and the definition for Constitution is a body of fundamental principles or establish precedence according to which a state or organization is governed. The Ace of Diamonds stands for wealth and represents the money to be used for the government funding of buildings, projects such as roads, schools, and wages of people who work for the government and for all people. As for money that is needed for the people or projects, the E, standing for Economics and the definition for Economic, is relating to economics or the economy. Justified in terms of profitability!"

Sondra: "Nice! Very interesting! Sounds like you put a lot of thought into this!"

Scott: "Yeah! But it only gets better. I'll read to you and just stop me when you want to break or when you have a question."

Sondra: "Okay! I'm ready!"

Scott: "Ace Services is a constitution governing the people's protection... It will establish a better well-liked society, for which we the people live... By bringing balance to the system in how we operate... I, Scott LeRoy Chally... see a vision of three different branches that will be known as ACE SERVICES... As we... I... read along... I will explain on how Ace Services will benefit this One World Nation... I will go over and explain three of the four powers that will represent our society... how in relationship we the people will be helped and why we need to uphold these powers... You will then see new laws come into effect... as well as some old laws be removed from the books...

You will see a medical system for the people... not for the unjust good of profits... You will see a well-balanced lending system... which will be fair for all... You will see how we the people will not be afraid to invest in our economy... Which we will have secured markets balanced and backed by the government... All leadership will be looked at, and some ethics of leadership will be changed to meet for the Commonwealth of the people... There will be a double-check system in all parts of the government... Civilian offices need to assure no wrongdoing is being done to mankind...

You may be asking how this can happen... Well, for the most part, information will be gathered and

obtained from the people by sealed collection boxes in every post office... As a sealed collection box is removed, another sealed collection box will take its place. Only the facility to where the collection boxes go would have the access codes and the necessary keys needed to open them... All the facilities that receive the collection boxes will take the necessary steps to safeguard the information obtained in the collection boxes... By keeping security of the information obtained at their utmost responsibility... Failure to do differently could lead to immediate dismissal and be prosecuted to the fullest of the law.

These boxes will be accessible for all people no matter how young or old, for the good or for the bad... The people will have the right to voice their opinions to be heard or at least suggest something that they would like to see changed... This will include if it's a sensitive situation, like a minor being sexually assaulted, rape cases, or spouse abuse cases, where they may be afraid to talk to the police. Small businesses, big businesses, companies, factories, and all alike should now worry on the way they operate... Now the common-day worker will have more rights and have the backing of the law on their side... All concerns will be addressed and carried out whether for the good or for the bad of the applying parties...

Laws will be proposed due to the effect on multiple complaints of the same nature... Or be considered for new operating procedures that best fits the common public... Tallies will be kept on how we can achieve a greater society... The people of Ace Services, Ace of Spades department would then work the people's suggestions into bills and laws that would best suit the people with a certain percentage of the population to come forward... If negligence or wrongdoing should come to an official in any of the Ace Services offices... That individual will be immediately put on suspension until the matter is solved... He or she will be upheld at the fullest of the law... If the one who puts the complaint forward is falsifying or is found at fault without reasonable doubt, he or she will or could face criminal charges... The employer at that time will have full right to fire that individual...

There will be what you call a scorecard or sheet with the rating scale from 1 to 10 made up for each person or for each complaint submitted or action... Ace Services' Ace of Spades Office will have to write a brief statement explaining what the proper action and outcome of each situation and what appropriate action is to be taken... All actions will be kept on file in everyone's records that's involved and at the appropriate Ace Services office for a minimum of three years."

Scott: "How are you following so far, Sondra?"

Sondra: "That last part, with the scorecard. You're saying there'll be a card that the people will be able to fill out at every post office. To concern a problem of any sort, that will be followed up on by the Ace of Spades department."

Scott: "That's correct. And the Ace of Spades department will also do a rating of how important it is and a written portion of how it will be handled."

Sondra: "Cool! Okay, continue!"

Scott: "So let's be keen about this, I say... If we are not looking out for one another, we could close our own employment due to the neglect of our own doing... In no way, shape, or form should blackmail be used against the company or an individual working for a company for profit or to better oneself... I suggest that businesses may want to look into profit-sharing for their workers to keep a more stable workflow being produced. All Ace Services offices will have the necessary information and updated policies and procedures for businesses to conform by federal, state, or local laws... All a business must do is make the call or look online to the appropriate office for the information they seek... At any time there will be a number for anyone to call for help or information... But actions must be

added to the proper slips for official actions to be carried out...

Here is a more defined list of Ace Services list of powers. Ace of Hearts shall stand for love and represent Americans... It's the most important of all the aces... Ace of hearts would be the branch that covers the people's protection to ensure all have assistance on medical needs... to include government health... free prescription's, family assistance programs, emergency relief efforts, and any other agencies that are similar in nature... No one should be deprived of these services or be left behind...

Ace of Spades shall stand for power... This will include lawyers, business owners, any executive officers, to the everyday worker, from the highest-ranking general to the lowest enlisted private and all leaders alike... This branch will govern fair treatment for all and ensure all have a voice to be heard as equals... No undue justice should come to any one person... Ace Services will allow all people to seek assistance throughout the land of any situation that may arise... All leaders, no matter how big or small, will have to abide by the rules set forth...

Ace of Diamonds will stand for wealth... These offices will handle all the nations' budgets along with all the payments allotted to people of the world and distribution of the money to the agencies of need... The adding of different files like credit and bank accounts, as well as federal aid will be handled at this office. Anything from the financial needs of the people and the emergency relief act along with investment agencies, that would be for the people...

Ace of Clubs represents entertainment... My best way to explain this is if you look at how kings would use jesters for entertainment or how the Romans would use their coliseums, it indicates false bearings and misuse of powers."

Sondra: "So, the Ace of Clubs would be like bars, sports events, bowling alleys, and clubs?"

Scott: "Yes, that's correct! Do you understand everything so far?"

Sondra: "Yes, I think so. It's sounding pretty good."

Scott: "As you can see, we the people can prosper and feel freedom at its fullest... As we share in the duties of our everyday life, we will know that we are free and equal to one another... Fairness shall be carried out across the land with the backing of the justice system on our side... We will do away with the heart-stricken problems that affect each of us... When leadership or leaders drift from the respective duties, it becomes a burden, and burdens we don't need... Some leaders may prejudice people without knowing all the facts by simply having a bias approach toward work ethics... Which they may not worry about the health and farewell of the workers... We need to seek out those leaders and try to train them to be good leaders, but if untrainable, we must replace..."

We, the leaders... need to listen to the people's wants, needs, desires, along with keeping their safety and their health top priority.... Leaders need to make sound decisions.... They need to be fair and just for all parties alike.... without bringing shame to one's workplace or to one's values.... For leaders to place immoral acts.... or beliefs in front of the people's common values, such as unjust and abusive power or for profits, prejudice in front of their own values... or emphasizing hardships on others for their own good.... all of this shall not be tolerated as a leader....

Everyone will have to uphold the duties for which they operate for the common farewell of the people... No one shall use unfair judgment toward one another... Common interest shows that we are all the same for we can make it better for all people... If the people get into unlikable situations where there is no help of the needs for the people that fall between the guidelines... of what we can

say is considered as fair or just plain hardship from such businesses and companies...

Zero tolerance for harassment in the workplace should always be upheld... It is a leader's responsibility to uphold and provide a healthy work environment... Leaders must not mix up social activity as a source of a problem... but keep what's fair for one and the same for all... Also keep a keen eye and ear of possible problems that may arise... If one should see something strange occurring, they should contact the one or parties that are involved before it progresses...

We might want to consider a 'don't ask or don't tell' policy... We should consider it for general living standards of what the people want... There also should be no harassment for the general population. Keep in mind... In other words, what a neighbor or someone we encounter should not pose judgment on one another for what he or she does on their personal time... But also saying thy neighbor you shall respect as long as there is no harm to come to thy neighbor... To include what may occur because of carelessness or misbehavior...

There'll be a justice system inside of a justice system to see that all justice is to be carried out fairly... New bills and rights for the people will be either adopted or proposed along with some of the funds being granted or be suggested to a higher court for approval within the government... The Ace of Spades office, when they act on a dispute, they should evaluate carefully and have a bipartisan opinion to adopt on the situation of each matter... which can allow the individuals to act on several different videos or actions given through Ace Services... Authorizing different agencies to solve the situation so it doesn't occur again...

This policy would use a three-strike method for the first-line supervisor position... The points will add up for everybody in the immediate chain of command for such said company, government, or business that it is applied to... If there were to be one person under the next level of leadership, the second level of leadership would have a total of six points... The third line of leadership would have nine points, and the fourth line of leadership would have twelve points... But if the first line of leaders were a total of four people, that would mean the second line of leadership would have a total of fifteen points... Three points per leader would be granted in a direct chain to equal the total for the level of points for leadership position... The highest-level supervisor would have to set up a point schematic scheme as soon as possible within ninety days of starting such a business or expansion of such a business...

If a company has as little as two people, you may have six points but no more than six hundred sixty-six points for a company that has a thousand-plus people... A line of leadership can branch off as much or for as many leaders as you have... But for large businesses it will cap at 1000 employees for the justification of the businesses or company's and even government establishments won't get off balanced within the leadership of said chain... So, if a company or establishment has more than 1000 workers, they will have to divide up their establishments...

I'll give you an example of how the point system will work... Let's say the first-line supervisor gets turned in to Ace Services due to a racial statement that he or she had made to an employee... which the Ace Services office decided for employee... The first-line supervisor will now go down to two points instead of having a three-point value... Also, the same supervisor will have to join some classes on racial harassment acts... If he or she chooses not to attend the class in the time that was allowed, they would lose another point along with the chain of command... unless that leader was removed from his or her duty... The whole chain of command all the way up to the president of the company would also lose a point, and it would stay on their record for three full years...

For each point that is taken away at said time... which only when the three years are up from the time of the said point was deemed to have happen... They will receive the point back to the three

points where they had started with for the first-line leader... No other first-line leader would lose a point, only the ones that are in the direct line of the one that got turned in... From the lowest to highest, it will always be accounted for any situation or incident that may come about... In rare cases there may be more than one point taken... Or a business or company may be closed for a short time until the problem is solved...

From the first-line leader to the top of the command that has a complaint against him or her, there could be as many as three points, or half of the total points taken away from what they would have been entitled to... So, they should be careful what they do as a business, and they should make good judgment calls...

Each business will be granted 3 points per tier level in the chain. So, if there are four different levels you would receive an extra 12 points separately from the immediate chain line which the strikes would be directed towards or against the business... If a business has as many complaints against it as the number of granted slots or the slots being maxed out, granting the number of disciplinary complaints that are to be allowed.

The disciplinary complaints that are against said establishment or business then will be taken out of the CEO, president, owner or of the one who is the number one in charge. The points they hold will be depleted as the complaints come in. If the number of complaints outnumbers the given number of strikes that are allowed – that is to say if you have went through all your granted points, you will not be authorized to operate in the public of the world.

Your license will be revoked to where no employee will be able to log in for work until 51% of the complaints have fallen off their timed strike, penalty point action of the main leaders given points. This is meant for everyone's performance records held in the Ace Services system...

The party that is not at fault could sue for money and/or push for criminal actions... Ace Services will do their best to make all complaints as fair as possible when carried out... The point system on the businesses will be looked at as a record of how they perform... Workers may check on the record of the points of said business or company before seeking employment with them. Any person may go to the Ace Services site, it will show each business performance record, which will be opened to anyone in the world to view... Or when the businesses have insurance or is looking for insurance, it may cost them extra..."

Sondra: "So if there are six first-line leaders, the second-line leader would have a total of twenty-one points. Is that correct? And let's say there's only a third-line leader or CEO of the company, he would have twenty-four points, also since there where three lines of leadership or tiers for that establishment it then will have a total of nine reserved slots to receive complaints on that said business before it affects the CEO's given points and if there are too many complaints against that establishment or business they will be closed down for a short time."

Scott: "That's correct. I believe you've got it!"

The days will be changed to match the moon's rotations around the earth to make the calendar correct. That is 28 days a month and that means there will be 13 months in a year. December will have 29 days and 30 days on leap year. Time will be moved back two hours, for instance, if it's 3 PM it will then be 1pm. A woman's menstrual period happens every 28 days. I believe that a soul starts at 22 weeks in the womb, so abortions will

not happen after 21 weeks. The only abortions will be in the consideration of the baby being born with defects that will cause hardship in living. No other abortions will be granted only if a doctor signs off on a medical form of the law accepting it as a defective pregnancy. There will be four, seven-day weeks in a month except the last month of the year.

Dale Legendary: "Okay, we'll move on! So, about this new world order you have, please tell us a little bit about it."

Scott: "Well, it would be called American Constitution of Economics, also known as Ace Services. It's a one-world government to cover all people rights for health, leadership, wealth and for the good wellbeing of the people. There are three aces that are used. The Ace of Hearts stands for love and is used for the welfare on health of the people. The Ace of Spades stands for power and is used in governing leadership and looking out for all in terms of fair justice. The Ace of Diamonds stands for wealth and handles all the money taken in or given out within the world and will regulate fair lending for all the people."

Dale Legendary: "Well, it seems like you got a handle on the fundamentals of the economy and structure for the world. But how would your order oppose world wars or countries that want to pose war?"

Scott: "A majority of military weapons in the world will be done away with. The majority of them will be disassembled, destroyed, salvaged, and recycled to use back into the economy. There will be no wars in the future. The world will be as one power. Everyone will be equal! After each country sees how the world policy will operate, they'll accept to the terms and do away with their military arsenal.

There will be up to 500 thousand soldiers spread evenly around the world on the seven continents to practice military warfare amongst each other. This will be like a game for the elite militaries to play out as a competition or campaign to show which county will win the Top Elite Military Force Badge Award for each year. Everything will be simulated and actual live demonstrations of live weapons down rang away from harm's way of the soldiers. There will be so many field events per the year that all the soldiers will participate in and there will be a score card keep for all areas in the training to see whom are amongst the best.

Every three months from the training and testing will be an updated list on where what unit will be at within the list. Each year after the tenth month of results of all skilled test that are performed, there will be the top two components from the list to verse each other in a simulated warfare to be able to earn the Top Elite Military Badge Award. You see the military can make this interesting for the public to watch on TV and follow their desired countries progression as they climb or fall in position to try to achieve top honor within the world.

All of the military around the world will have like a mirror print of the availability of the most sophisticated equipment in the world. As time goes on in the world so will the advancement of our military where it will always have the latest technology available in training and of stock piles. Only the 14-elite militaries in the world that I'll pick, will be amongst the ranks to operate these bases in the future. The soldiers from around the world can chose an occupation to serve for a life time in the military at one location and are able to travel around the world to do their exercises. Enlistments will be either 3.5 years or 7-year commitments when serving in any of the two military forces for the people.

Disciplinary structure of the services will be restructured to provide rights through all the ranks as equals per level of authority. There will be people that are incapable of achieving physical, and test

standards for said job or don't meet the standards of weight that will be required to achieve while serving. Other people from other countries that are not part of the 14 selected countries can decide to support which ever military force in the world. You see all forces will be of American and it truly don't matter what country you join, because they all stand for freedom.

There will be a stockpile of excess military equipment between the 14 military locations around the world. Enough equipment to power 6 times the active military force if ever needed to protect the planet from unknown alien activity in the future. All the people that are in the united world forces must be able to read write and speak English, due to the fact that all military schooling, equipment manuals and testing will be in English. Each of the elite 14 countries to be selected in the future will be able to choose whoever they wish for talents, or special abilities, or of schooling for each countries choice of selection to make up their military, all individual will have to sign a 3.5 or 7-year contracts.

The ranking system in the military for an officer or an enlisted side will be set up accordingly with set rates per rank with a revolving yearly percentage rate added of (.0205959100) in fair pay as you climb the ranks. After the age of 58, you will be able to retire with an adequate pension to get paid out for life. As an incentive I'll say which ever military country that takes the Top Elite Military Force Badge Award each year will get compensated 20% of their current grade of pay for the year and the percentage granted for the years in service allotted pay when receiving the award. This Will be entitled to everyone that participated in receiving top honor to be recognized and paid out in a lump sum for his or her achievement."

Dale Legendary: "Wow, you made the military a game! And you can get paid greatly to receive top honor in the military in the world. I'll be looking forward to follow our military on TV. What about people who die in training or on active duty?"

Scott: "If someone happens to die during the time on active duty while enlisted in any humanitarian service for the government whether its active duty of world forces or of assimilate warfare or troops assigned for humanitarian duties for the people. They will at the time of their death have their current pay grade and the time starting from the day of death total amount of time to be worked from that said person till the age of 58. Which all military troops will be paid out as salary. The surviving member or members of the deceased will get the retirement and all paid wages for what's entitled to be given to the surviving dependents. This means all the years that were left for working will be given in a cash amount for the retirement age of 58. With the 30% amount to be paid in for the retirement pension to go to the allotted surviving person or persons that will receive the money until they perish off of this earth.

If for say the person has five kids and the one that was supporting world peace dies, the person's five kids may get divided evenly for the money and pension to be paid out until they all have perished. Only the set divided amount will be offered to each surviving dependent at time of death of loved ones where it will not change. There will be an exception on the retirement age if someone dies before where the surviving dependent will receive the pension before the age of 38 years. At the time you enter your job information slip into the Ace Services system you'll be asked questions in relations to who you would like to leave your inheritance to after death.

Disabilities will be paid out after medical conditions that are to award a percentage for the severity of the handicapped or disabled person. Once the person settles for a disability, they are no longer authorized to hold a job in the military service. You will be able to work in the service with a disability as long as it doesn't interfere in performing your job. Retirement age of 58 if you have obtained any medical illnesses or disabilities can be addressed at that time of departure of service to receive a disability pension for life on top of your pension. Any one serving in the military their

family or directions by a written will, will not be subject to pay 33% estate tax to the government from the ones that inherit the death money from the government of the deceased.

There will be as many as 210 thousand troops in 80 different locations located near large cities for humanitarian reasons if any shall ever come up to look out for the people.”

Dale Legendary: “What if a nation chooses not to join your new world policy? Are you going to blow them up?”

Scott: “No, I don’t need to! See, under the new world government, all people will be registered into one database that participates and all who register to the database will get paid the costs of living by county or district that they live in. And if a country chooses not to participate, that means nobody in that country will receive the cost of living. Their economy will end up failing without the support of other nations until they accept to the terms. But remember the world has to be united by January 24, 2027.”

Dale Legendary: “Why does this date January 24, 2027, matter?”

Scott: “All I know are the numbers I figured out in the Bible equal to this date, what I understand according to the universal test that I’ve been placed with. What I read in the Bible that could come about would be three waves of asteroids, taking out two thirds of the population here on earth. That’s why it’s so critical by that date.”

Dale Legendary: “The way you put it sort of scares me. You don’t know what the other countries are thinking or want to do. They could destroy the world, you’re saying?”

Scott: “It takes the people to come together to make this happen for God’s plan. If we all believe, then there will be no worries.”

Dale Legendary: “You speak of how everyone will get paid. How are they going to get paid? Where are you going to get the money from?”

Scott: “Digitally there will be an unlimited amount of cash that would take care of the needs of the people or what needs to come about. For instance, like streets, government buildings, facilities, healthcare, education, retirement plans, and payment for each person’s cost of living on earth that is registered with Ace Services. Understand it will be a very, very large number. But there will be money coming in like when people receive inheritance, property assessment dues, retirement plans from companies paying in and then proceeds off of selling drugs, like marijuana and cocaine, officers of the law writing tickets.”

Dale Legendary: “You’re talking about making money off of drugs as a government? I can maybe see marijuana, but cocaine, isn’t that a little extreme?”

Scott: “Not really. See, everybody is in the same database with authorizing a rations card to each person within the system. It works the same way when they want to buy some marijuana or cocaine. Maybe, let’s say, for marijuana they can receive a half ounce once a week. Each individual in the world would have the access to pull out from a bank that sells marijuana or cocaine. It’s just that it’ll be restricted to buy only a half-ounce per week for each person from the database which will be regulated. There will be three rates of quality for instance if the THC level is below 20%, then from 20% to 25% THC, then 25% and above THC will be a different price, like \$25, \$35, and \$45 for a quarter ounce of marijuana. Now it will be opened up to so many dispensaries per county or district locations authorized through Ace Services office.

This will allow the public to get involved if they would like to be a grower, supplier, or merchandiser. There has to be a full detailed plan presented to Ace Services office of location, your contact suppliers, and the amount of product you will be able to supply on a daily bases in order to operate said establishment. Only authorized growers and sellers have got to be registered through Ace Services Offices. Realize the public will be buying the quarter ounce 7 grams of marijuana shake or flower for \$25, \$35 or \$45 but the establishment will have to subtract 33% cost of the sale to go to the government so they have to purchase it for less than \$16.75, \$23.45 and \$30.15 on a quarter ounce because this is what they would receive for providing the shop for it to be sold at. Realize your gummies, vapes, lotions, CBD products, butter, resins and other THC products will have to be regulated by ration so much by week or month to be offered to the public.

For instance, another example would be for cocaine to only receive nine grams a month. A gram would be priced at \$50 and an eight ball of 3.5 grams would sell for \$150. 33% would have to come off of each sale where the product will have to be produced with a lesser profit margin. Each person would not be able to buy more than 9 grams a month from his or her account. Of course, there will have to be some testing for the level of potency for cocaine to be distributed. Maybe it might be cut 50-50 with something else. It would be a really hyped-up cough medicine for an example, but still legal and safe to use. The government will monitor the usage and quality of cocaine throughout the people, but no other drugs would be acceptable through the government. For instance, it would be illegal to have crystal meth, heroine, LSD or acid, and other illicit-type drugs.”

Dale Legendary: “Okay, I can possibly see the drugs work, but won’t the economy get overinflated with having unlimited amount of access to pull money from?”

Scott: “You see, there will be like a tariff put on basically five major categories. They are rental properties, new autos, insurances, utilities, and food. They will not be able to fluctuate more than 10 percent per year on their prices. They will be governed and controlled by the district Ace Services office of Ace of Diamonds. There will be one delegated person to watch out for prices within the Economy working in the Ace Services; Ace of Diamonds department from every county or district. Where there will be representatives to look out for fair pricing to up hold the law. This will be one person per every 50 thousand people in a county or district.

People who have rental properties will not be able to raise their rent more than 10% per year for the renter and not more than 30% in ten years. The same applies for all the markets and establishment throughout the world where it will fall into the basic 10% rule where you may be okay for 3 years and then the government will control your pricing and you may be subject to fines which you may not like. Like for giants where we will use Amazon for an example where they control whatever they chose to swindle money from. Like for instance the book market an author may get 75 cents per book but Amazon can sell that book and make 4 to 5 dollars from that book of the authors which is not right. In the New World Order Amazon will only be able to make - and this goes for all the advertising markets, agencies, subscription and wireless services out there in the world - no more than 10% cost from selling the product or service that is at hand or marketing of item or service to be sold. And for all authors out there in the world you will be able to charge up to 33% of what the book cost to print. So, if a book costs \$8 to make you can charge \$10.64 for the book, making \$2.64 per book and Amazon can sell your book for \$11.70 with a profit of \$1.06. All products being manufactured can charge up to 33% above the cost of producing the product.

All construction can go by the rule of thumb of saying double the marital expense for the cost of labor to perform such construction not to exceed 200% unless it’s an accepted bid. All financial banking or credit services in the world will have to abide by the standards provided in this New World Order that no home or property loan cannot be authorized to charge more than 7% interest for a rate and a credit score of 530. And if your credit score is above 600 from any official credit site you will not be required

to pay more than 5% on a home or property loan or 2% cheaper rate depending on the average interest rate. And if the score is less than a 530 no institute has to give out a lone till you're at 530 or above of your credit score.

Credit Cards or personal loans cannot exceed more than 12% of the annual interest rate. Having credit cards at more than 28% is just plain greed and evil in my eyes and should not be accepted in the New World. To qualify for these loans your credit score can be as low as 500 and anything less, the lending agency does not have to lend. At 600 credit score you will qualify for 8% annual percentage rate also any score higher than 650 will be granted 5% or less annual percentage rate for personal or credit loans. Realize before the lending agencies of the world would have to try to collect debt that was lent out. In the new world all any agency has to do is show in a complaint to one of the Ace Services by placing it to a suggestion box that are located in every post office of proof of 6 missed payments in a row or 8 missed payments in a year. The justifiers will set up a judgment against whatever individual who falls into this category. There will be a 25% allotment amount of entitlement of pay to be garnished from the delinquent individuals monthly income until said debt is paid in full. It should also be noted that loan and administrative paperwork will not exceed 5 pages on documentation that needs to be signed.

Just because you put this judgment on an individual doesn't mean it will automatically come out of the individual's money. Only the earned money of the individual if they hold a job or at the time of them receiving their 1st pension at the age of 38 is where they would then be paying off whatever debt for judgment that was placed against them. This will happen through the Ace of Spades department as one of the justifiers duties to assist the public of rights and justice. If a person doesn't work a job and there is no other income coming in for said individual besides the cost-of-living allowance, the lending institutes shouldn't lend because they may never get their money back if the individual chooses not to work in life. If you control those prices on the categories I listed for the economy, it won't matter if the economy is overinflated with money."

Dale Legendary: "It sounds a lot like socialism with a dictatorship, is that how this new world order is going to be, a controlling order?"

Scott: "Well if you look at socialism. There will not be what you call socialism in this New World Order. The government is not taking money from the rich and giving to the poor. Everyone receives money from the government. There will be no one who feels left out and the world will have to be united as one for peace to prevail. As far as having a person in charge of the New World Order, there will not be one directly taking orders or giving orders for laws. There will be a member voted in every seven years that would come from the Royal Family of mine for the world council to be in charge of."

Dale Legendary: "You say your Royal Family will hold this spot?"

Scott: "Yes, preferably the future generations of my family. If there ever shall be a situation what I consider the royal members of my family, choose not to run for the seat to hold 151st vote on the World Council and to make decisions on all tie votes across the world, it would be opened up to the public for office for said election. The sole purpose of the one in charge of the World Council duties are to assure proper actions for laws are taken into consideration on all aspects of the people's concern. Also, with the cabinet to vote on the necessity to allow greatness for the people. The one that is elected from the royal family to hold

this position. His or her duties will include to make the final vote on all tie laws to come into effect. That's to include whether it's city, county or district, state, country or world voting. He or she will also make the final decision on world laws being selected to be voted on for the greatness of the people with the 150 board members. There will be four different areas of voting within the world. You have your county or district which is local for laws and your state laws will be at a higher level for different voting, as well for the country and world laws for the people.”

Dale Legendary: “You worried me there Scott, about this being a communist ran world order you have come up with. There's really nobody in charge of holding office for the world but you say just the people make it happen. Could you elaborate on this for me please?”

Scott: “Well it's the people that speak up of what they want for changes, new laws, desires or problems that they submit to the suggestion boxes in any of the post offices of Ace Services. Ace Services will have collection boxes in every post office across the world for the access of the people to submit any problem of any situation. I made it simple for bills to become laws.

It takes 1% of the population for county, state or country or world to submit the same in action or pursuant of a new law but will cap out at a million votes for county, state or country. Realize in the post office's there will be like a small computer display set up that will load the credentials of the person by their chip that was assigned to them and for submitting the complaint or what they want to address to Ace Services by typing it out or by voice recognition. It will then be able to be printed from the device in the post office to be signed and placed in the suggestion box for Ace Services to act on. Also realize once a person had addressed something to be consider for a law, it will show up for the city, county, state, country or world on the Ace Services site under proposed laws for all to see.

If someone wants to agree along with what is to be addressed, they will be added to the proposed order. Once 1% of the people for the proposed law for desire of change of lifestyle to come forward. Then it will be six days or less where it is turned into what it will look like as an order or law by Ace Services office. It will run for 30 days for people to view and when or if 10% of the people of the voting pole accept yes and only yes to the order whether it's City, County, State, Country or World. It will then be presented as an order or law to be voted on for the next 30 days for the people to say yes or no to said bill.

After 30 days when the time is up for all to vote, it will then become a law or thrown out. Remember if people want to vote they have the access through their phone on the Ace Services site, not all people have to vote only if they like. There will be an activation date placed on all of the initial suggestions for proposed law that is submitted and it will only stay listed for 1 year on the site. This is for the people to act on no matter how close it is to be considered to come forward as a law or order.

When you're on the Ace Services site you will have a menu to have access to different venues within the site. If you're in the proposed orders or laws section, where it will show each person's order of suggestion

from a list and will show a count of all the people from that city, county, state, country or world as well the number of people that had agreed with the order. It will show a count of the people that have agreed with the suggestion for law and it will show the bare minimum of what count of votes are needed to advance the order. These laws will be decided by the people with easy accessibility.”

Dale Legendary: “How will you manage this?”

Scott: “You see everyone is in a database with a decryption number address to them, this is for security reasons and a number with it for personal identification. There will only be one identification number to each person in the world. There will be an accessible site for all people to look up anything within the government as far as laws, rules, sites for voting that they can access through either a computer or personal cell phone. All the peoples medical, criminal, work or income info, schooling records and ration records, all types of banks or credit ability’s, an area with in the chip. You will be able to list your utilities and payment accounts that you may have. This will also be accessible through your chip that is assigned. Along with a genealogy record of all who are related to you by DNA in the world on this site. You will able to add as many pictures and things you would like to each of the relations in your family tree. This will include yourself for the individual to look up in this new world. Only changes to any records except your family tree pictures or private items you list for each person’s database can only be altered at the appropriate Ace Services office.

Ace Services offices will also attach as many as 7 credit cards or financial institutions to each person’s personal identification number that they will have for access to pull money from or to make charging purchases. Each person will have a record revolving their expenses as they live life. You can set anyone of your financial accounts as a constant for your chip or at any time you’re able to select the payment to come out of any of the financial accounts at time of payment if it has a creatable balance to do the transaction. Privacy of an individual's record will be only available when the individual allows it to be exposed. So, there will be eight areas within your chip that you will have access of your personal files.

There will be hubs at said locations that are programable to allow access to each one of the sites within your chip. Depending if it’s medical, criminal record, charge, schooling, work records and log in times of where you work, along with showing where you’re at as far as what was paid in for retirement as time goes on and rations.

Only people of their county for a suggested bill of said county are able to vote, this includes whichever law at which time, will also have GPS location in order to vote. This will show the individuals’ identification number at whichever site which he or she would then be logged into. So, it only takes 66 days for a law to come into effect. With today's technology elections can happen relatively quick.

For world laws to come into effect it would be about 5,000,000 people needed to be recognized for selecting such laws to be voted on by the world council held once a month. It may take up to 60 days to research the order that’s being addressed by the people for the world government to view. Representatives

from the 150 countries then would vote on the order. If it passes the world council it then would be available for the people to vote on said law before it becomes official. It shouldn't take more than 90 days for a world order to come into play."

Dale Legendary: "That sounds incredible! I can see that working smoothly for the people."

Scott: "I had also thought the people would like to know their geniality of all whom they're related to. I'll have everyone take a DNA test to keep their family ancestry known as history goes on in the future. There would be a family tree showing all the blood related and adopted relatives of generations of the family and all who they're related to on the Ace Services site of your chip."

Dale Legendary: "I like that idea! Is there any more of the new world order you would like to tell or say to the people?"

Scott: "Yes, as far as any businesses or companies in the world, they will have to back what they offer as a service or product or they may receive stiff penalties by Ace Services if found at fault. Companies that ignore the peoples right for being fair or just when they operate, they may be brought or ordered by Ace Services to appear in court to be settled with huge fines. You see all businesses will have a license to operate by Ace Services, and if they don't have a good record with the way they operate with the people. Ace Services can revoke their license and that business will no longer be able to operate.

It will be up to the people that makes complaints against the businesses out there. Ace Services will take each complaint serious from each person and will be resolved by a 5-person Justifier panel of Ace Services, while some businesses may be addressed to a court for multiple actions against such businesses or companies from the people to resolve the problem. When a business has too many complaints against them, they will be shut done immediately not allowing the employees to log in to work for pay by the Ace of Spades Department within the system.

The system will acknowledge if there are too many strikes against any agency or business to where that establishment or licensed business will then have to appear in court with in three months or 84 days to decide their outcome. The justifiers will set up usually three different actions to choose but, must only select one option to vote on by the jury of the court. The 1st option to select may say shut the licensed business down permanently by revoking their license or the 2nd option may say close the business down for a short time with a set fine they would have to pay or 3rd option for the jury to choose from may say the business is authorized to function within the economy with no finding of serious faults. The court may feel the company or business just needs a warning and will allow them to operate. Just like with big businesses out there in the world they will be regulated by Ace Services along with all the people to abide by the rules I set forth in this policy.

Now Amazon on the books side of the house they make a standard of 35% on every book sold through there site. I don't know about you out there in the world but I think that's ridiculous what they're getting for something they are just marketing for you. So, the new rule of thumb will be you cannot charge more than 10% of the product or service you're providing for marketing.

Now a service of plumbing, electrical, construction and similar will basically charge by hourly wages to perform the job or bid jobs not to exceed 2 times wages per the cost of materials. If an advertisement company like, YouTube or Facebook offers an advertisement campaign to reach 100,000 people for a certain price. That advertising agency must provide the service of what they said they can do. If they don't fulfill their service 100%, there will be a strike against that affiliate and they will have to refund all your advertising because they promised a certain amount of viewing to the public which they must honor.

See with Facebook and other companies similar in the world, they really don't have a contact for problems or support to talk to someone about your problem, so they deny you a solution to your problem. They have an automated voice mail or automated spreadsheets to try to solve your problems which just makes it frustrating. Businesses in the world that turns the publics needs away by not providing a help line will find out they may be closed down if they receive to many complaints to Ace Services justifiers office that could have been saved by having a receptionist help the individuals out. All manufacturing can charge up to 33% over the cost of making of the product to the public.

There will be an electronic gambling commissioner in each destined Ace Services office to regulate casinos and electronic poker gambling sites that that receive money from the people. The casinos will not be able to turn up their profit margin with in the electronic gambling slot or electronic poker games to receive more that 10% profit. You see there will be a program written up to show a gaming slot machine in a casino the amount of cash that was received in that machine and the amount of credit which was given out. The difference can't be more than 10% profit in a 28-day period averaged out through all the electronic games from that casino or establishment. If the casino breaks the rules there will be penalties such as a fine on top of getting a strike. Too many strikes will close a business door to the public. All electronic gambling for money will be monitored by Ace services and the gaming commission for fair play.

Insurance lawsuits received for death cases will change for a standard for all people to get the same entitlement as the next person. For instance, if a person hasn't held a job in a year, they would be entitled to receive if they died at 28 years of age in a car accident. Death settlements will not go to court to figure out a sum of money to receive. It will all be calculated by a standardized form for all deaths to be figured out by a lawyer's office to what the deceased family members will get or presented to the Ace Services office for the Justifiers to figure out for each death case.

The person at 28 with no job, where the assigned dependents will receive from the accident \$675,000 for his or her settlement from the insurance company. When it's longer than a year since you held a job, you will only get 15 dollars an hour for your wages as a standard. If you work a job that is less than 15 dollars an hour. The insurance amount will not be paid less than 15 dollars for the hourly wage for anyone that

parishes off this earth. At 28 years old you would still have 30 years of work Infront of you so at 15 dollars an hour times 1,500 hours in a year will equal \$22,500 for one-year, times 30 years equal approximately 675,000 dollars to go to the surviving dependent, dependents or loved ones.

If you held a job, the rate would be the last hourly wage worked so if you were making 33 dollars an hour you would make \$49,500 per year till 58 years and say you had died at 52 of a car accident your dependent will get approximately \$297,000. If it was a child under 18 years of age you would get the standard 15 dollars an hour times 1,500 hours a year and you would calculate it for 40 years this will give your love ones 900,000 dollars. The insurance is based off of wages and years left to be worked.

I will expect all people to try to commit themselves to 40 years from the age of 18 of schooling and work for a commitment in honoring God and the society we live in. There is no compounded rate per year just the last wage worked from the day you had dyed till the retirement age of 58. The max entitlement that anyone will get is a max wage of 150 dollars per hour, times 1,500 hours, times 40 years to equal \$9,000,000. If a person can't figure what hourly rate, it may be figured out through salary or of yearly income paid in to figure what amount to get paid by the insurance.

If a person doesn't pay in or haven't had any pay added to their retirement in the system it would only show you as unemployed. Just like with movie stars if they get paid for acting by set amounts. Even though they may make a lot but, if they don't pay any money into their retirement fund through the government, they will only receive \$15 dollars as a wage and that would be what that individual would receive as a death benefit that passes away due to an accident.

You see certain agencies that need to view the wages from the deceased or anyone will be able to look with given access from the Ace Services site to be able to look up anyone's status of their wages that will be up dated and current, with start date of job. And if they're not working anymore it will show that last worked wage of rate of pay and the last day that individual had worked.

I suggest the insurance companies out there in the world to adjust the rate for insurance to reflect the people who make more money should pay more than a low paying job. If a person is killed in an automobile under any joint plan as a member, like a parent losing a child under 18 years of age, will not have to worry about their insurance going up. Accidents or deaths throughout the world will not have court to decide what will be settled.

The Police will make all deciding decisions on all traffic accidents and fender benders of any sort. This will show each accident of the one at fault or the officer may state 50/50 on an accident report. If the person doesn't feel the ruling is adequate, they may submit an action through Ace Services suggestions boxes in every post office. This way an action will be looked into by the Justifiers where they will be the final decision to contest it if the justifiers department didn't assign a court to solve. It will be a simple mathematical problem for all people equally the same.

Any age after 59 years old, if you retired at 58 will get 200,000 as a minimum when they have vehicle coverage from any insurance company. All the people will have to list a minimum of one person and as many as 10 people to address as beneficiary survivors, when you sign up to establish data for your identity at the Ace Services office. It will list 10 slots where you can fill in whatever names of your liking along with a percentage that can be adjusted between the number of beneficiary's listed to the nearest 1%. This will allow you to authorize whatever percent to each of your love ones.

If you have a will set up from a lawyer's office the policy has to be added to your records in the Ace Service system at the timing of its completion or it will be non-existence to the system to react on and will or will not hold priority and may be rejected if it comes up after a death had accrued.

If a person does not have coverage while driving and gets into an accident or by being pulled over, they will have to immediately serve 3 months in jail with no exceptions about it. You will no longer have to show proof of insurance to the authorities, because they will automatically know if you have insurance by when they scan your chip. You see the officer will be able to look your identity up through your plate number on your vehicle and also when the officer scans your identity chip to show your criminal history, license plates, if you're current on your driver's license, your proof of insurance along with your contact info.

If you have killed someone in a crash and found to be at fault as being the cause. If you did not have insurance; you will be forever in debt for all who have died in the accident or injured with a disability and it will be garnished from your employment earnings each pay period until the debt is paid in full. Now that could be a couple of million you would be entitled to pay if found at fault. So don't drive unless you have insurance.

The money received from a death of a loved one will not have to worry on paying taxes on the money received by the insurance, but all other estate value of the one that had died will have to have 33% of assets paid to the government to exclude the money you would receive from an insurance company or government from a death claim. This is an order for all insurance companies to go by, for the death standards and disabilities to be paid to the public.

If anyone working for the government shall happen to die during their work hours at work, they will get paid out through the government of what's entitled by policy to go out to their surviving dependents just as it is figured for insurances of accident death claims. All life insurances will be monitored to assure they are not receiving more than a 10% profit margin each year for the services they are rendering to the public.

If a person gets disabled through an accident or while at any work location, a percentage will be granted for the lifelong injury starting at 10%. It will only increase by 10% increments like 20%, 30%, and so

forth depending on the severity of the injuries. From the time of the accident to 10 calendar months is when you may appear in front of a medical board examination to figure if you're entitled to receive any compensation for your disability at hand. They will have fair standards to go by to allow a disability to be paid.

Let's say someone had a car accident and ended up with a bad head injury that cause them mentally not to function properly in life. The board will grant full disability, 100% to the one that has the injury. Any person that receives a disability through the medical boards across the world will have an option. They may select whether they want the whole amount of 130% of entitlement as a lump sum from the insurances or government to be paid or have 30% of the entitled amount to be paid into their government retirement. Where they would get whatever percentage that was granted from the board.

It's the same for disability as it is to figure out a person's death with wages they may have earned for life of employment. So, it will be the hourly rate times, from the time of the accident till the age 58 per years of work of 1,500 hours, then you will get paid by the percentage that was granted from the board. If you were granted 100% then that would be the same entitlement in money as if you had died. There will be an extra 30% to decide if you want to place it in the government retirement plan or take the cash. A death may be cheaper for an insurance company than some disabilities to be paid out due to the fact that they will have to give you the set amount for cash to be granted by percentage of a lump sum. Since you will be living, they will have to match 30% of the lump sum of what you would get paid to the government retirement plan if selected.

Insurance companies will not hold any medical condition for a difference in rate on any policy. If a person has bipolar, he or she will be able to get the common rate for the life insurance policy equal to all and just like smokers the insurance companies will make a common rate to charge all people equally the same."

Dale Legendary: "That's good to hear, because there are a lot of corrupted businesses out there that don't care about the people but just care about making a buck. How will you know for sure if the 5-person panel will be legit for the complaints of which they will have to solve? You may have some that think they're always right on what they may think towards an action."

Scott: "These people will be known as Justifiers for Ace Services and in order to become a Justifier they will have to pass a test that will hold common values of disputes for the people from the Ace Services office. The test may be determined by a study for human rights and approved by me to say what's right with the utmost security of the test answers. They will be stored in the Ace Services secured database for the results of the test answers. The people taking the test have to have at least 90% correct in order to become an Ace Services Justifier. No one will know the correct answers but the scan machine that the test will be placed into in order to check. We will call this test, Justifiers Test.

There will also be a double check system within Ace Services to ensure all people are taken care of appropriately with no wrong to come to anyone. 5-person justifier teams will be set up for each county

as needed saying 2 teams for every 25 thousand people. They will annotate their findings of each situation and will vote on whatever matter which is addressed.”

Dale Legendary: “That's interesting, so with a county of 1 million people or more they would have more than 400 justifier's working for the people or 80 teams. But you said there was a double check system. Can you elaborate on that for me please?”

Scott: “Realize as the reports or complaints come forward to Ace Services there are people to get and organize what's presented to the five-person justifier committees. The justifiers will be doing the investigation on each person's case prior to voting on. These justifier teams will be switching up monthly to be with different justifiers in each of the Ace Services office to vote on the people's rights. Most cases will be acted on and resolved in a week. Some cases may take longer due to the investigation process. Either way the teams are in the same building where they may have to allot a time to decide on the case at hand. If they had started the case together as the 5 justifiers and it will always be from start to finish with the case. They will associate with each other about the case at hand but when they're accepting to all the evidence and ready to vote. They will have to complete the process in order to allow the 5 justifiers votes or actions to be decided on as the 5 justifiers to set forth discipline if needed. This will include new bills or laws to address and filling judgments on different people for not making their payments to investment agencies.

There will be set standards for everything to be handled smoothly for the justifiers decisions when they come up with their corrective action or duty they may provide to the people. Like for instance, if they see so many of one type of action they're dealing with on a constant and if the Justifier sees a better solution to the problem, they can approach it to come forth to better the people as a law if they submit it or pass it through its ranks to set forth for the people to vote on.

There will be a Chief of Staff assigned to each Ace Services location to be able to have solid knowledge of the people's needs and actions. So, for these people to hold these positions within the government they will have to have an I.Q. test taken and be able to achieve a 115 score or better on a scale of 1-160, also there will be a Justifiers Test where you must achieve a 90% to qualify. The age for the Chief of Staff position would be from 35 to 65 years old. These positions across the world from different levels of populated locations of Ace Services offices will be paid greatly for holding this position. It will start at the lowest level of \$65,000 to \$165,000 for a large office in a large community of people.

All actions to be voted on will have two different justifier teams from the same office to determine the outcome for each complaint. There will not be a double punishment for the outcome of the two justifier groups deciding actions for the participant at fault. The choice of the lesser if there were two different actions presented from the two justifier teams will be decided by the one receiving the disciplinary action. The selection of who will get which cases will be done first thing in the morning when the justifiers will start their day out as assigned teams and they will go in order to pull out one card from a bag until all actions or slips have been accounted for that was in the post office that have been transported to the Ace Services; Ace of Spades Department.

Some days there may be many actions to address and others days maybe not so many. Realize depending on each person's case the justifier's have the right to appeal their findings to a court depending on the seriousness of the case. They will set up options for the court to vote on each case submitted. These are only local, state and federal court.

Judges will no longer make any decisions for the ones that appear in court. They will just assure the trials are properly administered through the law of the people and the justice system. This will be set up by the justifier's office for simple selections of the jury to decide the fate of the one on trial."

Dale Legendary: "It sounds like you have a handle on all that, I can see it working smoothly for the people. I can't help but think how you said the economy will basically be controlled by five major areas, like housing, food, new autos, utilities and insurances that they will not raise more than 10% per year. But I can't help but think in 10 years if they raised 10% of the product per year it would then be a hundred percent of what the product is worth in 10 years. That could be dangerously bad."

Scott: "Don't get worked up Dale, there are safeguards within the system. At any given time, any product out there in the world where the consumer complains that it's too expensive and if it's researched by the Ace Services office and found out that it has increased more than 50% for sale of such items or product. Then there will be freezes put on such product whether it is the producer, supplier or retailer that is at fault by the local Ace Services office. If such products are over 35% increased, they can be placed on the Ace services app to vote on for the people to freeze its value for seven years.

There will be two voting sites through Ace Services, one which will be of election voting, product and miscellaneous and second is of laws and rules. Whether they're production, suppliers or retailers, if Ace services mandates a price for them to abide by for such product that they sell. If they choose not to follow the mandated laws outlined by Ace Services, they will be shut down and their license will be revoked to do business."

Dale Legendary: "Well, thank you for your time today, Scott. We will have to wrap it up for today. Is Scott Chally the Messiah of the world? It seems like he has his cards in order. Maybe it'll work, maybe it won't. Time will only tell! Thank you for tuning in this week to CNN Newsweekly and until next time. This is Dale Legendary signing out."

Walter Davis: "I would like to hear more about your medical program for the world and how it will benefit the people?"

Scott: "Sure, no problem. The medical side of the house of cards will be taken care of by the Ace of Hearts, paid out by the Ace of Diamonds. It will be for the people's protection in healthcare that no one will be left behind. There will be no such thing as preexisting conditions to stop you from getting medical assistance. Medical practices will be looked at. The government will come up with a common value for all medical practices performed. For instance, if there is a specific surgery that is \$15,000 at

one hospital or from one doctor and another doctor performs the same surgery for \$10,000 and a third doctor performs it for \$20,000, it will be taking on an average of \$15,000 for the government to pay out for the doctor of said surgery as a common.

We will gather all the information for surgeries, and all types of jobs within the medical field for it to function accordingly. Also, with all procedures that can be performed within the medical field, like x-rays, lab work, along with any type of test a doctor can order up for a patient. This will be in the Ace Services system of the Ace of Harts department, stored in the database accessible to all who work in the medical field.

When you go to either your primary doctor, dental, vision specialist and or hearing specialist the chip you maintain either in your wrist, hand or of a chip card with picture, which will be given to you. Of the two choices for your identity to allow access to your files at which ever location by using a small computerized hub for connection to Ace services database. It will look like a small screen maybe six inches by six inches to show a display of functions to select on the device of Ace Services hub that will access your medical files. Realize this hub you will either swipe your wrist or hand where the chip is located to bring your info up or use your card with the chip and picture on it depending on which one of the two options you decide to go with.

Every time you log in to any hub or device such as your cell phone the first thing you will have to do is either have a four-digit number code to allow access or if a person wants to use fingerprint or facial recognition access. Access will be accessible on whatever device with a standard allotment time of ten minutes to say connected at a time where after 9 minutes 30 seconds a small window will pop up asking if you still want to stay active on the secure Ace Services site. You can change the time settings for a longer or shorter length of time to stay on.

You see every device in this new world will have to have a chip within the device to be programmed to allow encrypted access to the ace services site which will make it secure to all in the system. For example, when you go to the vision specialist and after your identification number has been swiped or scanned and a 4-digit number has to be entered or fingerprint of facial recognition then it will show a list of options to choose from the main page of a menu of your files you hold. You can choose from general medical, vision, dental and hearing. You then would select vision to be seen at that particular office. All areas of the medical records or any of the Ace's sites which are addressed for each person will be accessible at any time for that individual.

All the info kept on each person in the world will be secure for no others to have access, unless authorized by the individual or deemed by court. There will be an average that we will come up with on all medical procedures and jobs in the medical field from across the United States. This will be excluding the rest of the world along with countries of extreme poverty. The rate of pay for jobs and procedures to be paid out by the government or Ace of Diamonds department will have to be established using the United States standards of the economy.

Walter Davis: "That's good for the policy to go off of an economy that is strong for the world. I'm sorry, you can continue!"

Scott: "Realize in the system there is an itemized list that goes to ten thousand that will be accessible through the people that work in the medical field of the government. From 1 to 500 on the list will be classified as the different types of job classes and pay. Everyone that works for the government or within the world will have to register or have a job data information slip written up prior to employment.

You will need the name of the person appointed to the position, the named position he or she has

been awarded. The listing number of the job in the system, along with the facility or location of business of where the individual will be working at, an hourly rate of pay granted and the name of the one that appointed the position. There will be a standard documental order form in the Ace Services database system addressing you the job position authorization of whatever facility you work at. This will have to happen prior to working in that job set up by the appointed human resource personnel or assigned individual from whatever establishment.

When you punch into your job at the hub for Ace Services system, it will monitor the hours worked of your classification you hold in the database. The next group of numbers go from 501 to 2,500 these numbers are for any doctor to have access to an itemized listing of different procedures that can be performed or ordered up of whatever, like lab test, vaccines to administer, x-rays or any medical treatment within the system that would be in need to treat said patient. The appropriate people in conjunction of each test or function that is needed to be performed. This will be in the order as it is ordered up to receive their part of the function. Whether annotating hours to perform tasks or ordering supplies to whichever establishment worked under.

Ace services system will automatically pay all payroll and services rendered which will get paid out within two hours past midnight on Saturday night or Sunday morning at 2 am for each end of a work week, which will always be paid out on a Sunday. Doctors will be able to perform their practices in the similar way as they are getting patients and income now. But they will have to annotate each patient's appointment with all documents that are done on that said patient with in one week from the said appointment. Also, with all medical information on that individual of the appointment will have to be added to Ace Services database for each person that goes to a doctor. Once the person scans his or her chip of their medical there will automatically be a weeklong window that will be accessible from that individual to that hub or linked computer to the Ace Services site of that licensed practice for the doctor's secretary will be able to add all the findings, etc. lab work, x-rays, exams, medicine prescribe so forth on each patient.

The window of access to the Ace Services site after 7 days will automatically close and if the facility, facilities in conjunction in performing each step that is ordered up by a doctor. As test and of x-rays, MRIS, Ultrasounds, lab work or any exam or test when ordered up by a doctor and then the Ace Services database will allow it to connect the next step in the process to each location in the chain. If they should happen to fail to complete the procedure as directed with failing to comply by not filing information, test or recommended results of that patient being seen by said time, unless an extension of time is granted by Ace of Hearts department when requested. If not, then there will or could be a strike placed against said doctors' facility or the appropriate establishment operating performance record which is constantly being monitored from the Ace Services Ace of Spades department. This will show a daily revolving updated performance records of all licensed businesses out there in the world that are authorized by Ace of Spades department to operate. This will show all the businesses how well they're operating. A medical facility will have to deal with the mark against the doctor's performance record, secretary's mistakes or any complaint against that said facility or practice.

Any complaints about a medical practice location will affect all who are employed through that facility and will half to consider the leadership chain of responsibility as a business. You will see a competition in the medical field where all will perform by the rules set by Ace Services; Ace of Spades leadership branch. Ace of Spades department of Ace services will keep track of each establishment record automatically daily as the complaints come forward to be decided on.

This will be done by Justifiers of a 5-person team within the local Ace of Spades department to research and vote on each occurrence. As negative complaints are decided, it will affect all who are associated with that medical institution or facility where complaints will be kept track of as a record on how they perform as a whole. There will be six levels or six different level tiers of all the acting medical facilities in

accordance to prevail in our society to be equally balanced. This will be equal for all when complaints or discrepancies accrue.

The first level tier will consist of having 10 or less individuals for said location of medical practice that are authorized to operate by Ace Services. The next tier would have 11 to 25 people for the establishment, then it would go from 26 to 50 and then it would be 51 to 100 people in conjunction in working for that tier of establishment. Major hospitals will consist of 101 to 500 people working for that establishment. Large hospitals or medical facilities that consist of 501 and up of staff workers working for that establishment.

All in conjunction of medical workers for the government, medical supplies, medical prescriptions, procedures performed from doctors and nurses that work for whatever facility will be paid out by the Ace of Diamonds branch but will also be monitored by the Ace of Harts to assure all medical documentations and procedures are being properly administered for the people. And the Ace of Spades will be where all people that work a job for whatever facility and or businesses will have to bring in documentation stating to whatever job is to be assigned. Also giving the establishments from around the world the authorization to operate within the public.

Ace Services, the Ace of Spades department will also handle all complaints, suggestions for laws and verifying the leadership branch for each operating business or businesses within the world. All businesses except the government will have to provide a debit account for the Ace services database system to be able to debit the payroll of their employees. The business credentials will be recorded in the Ace Services Database system at the time when they become established. So, before anyone can go to the Ace Services office for a job to be entered in the system from any establishment or business, that business has to be in the system first. There will be a percentage paid out of the property assessed value of each medical facility.

Supplies, work rendered is of one thing, but the medical facilities or property's will have accessed real estate values of each medical property within the world to be paid out at .0666666666% (be carried out ten places past the decimal point) broken down by weekly to each establishment each year. Whatever the assessed value for each property that is in the computer system to start with which is handled through the counties assessor's office will be what will get paid starting on the 1st of January each year. After the assessed values are entered in the Ace services database it will always be updated as the world revolves or it can be updated through an individual request like if there was an expansion done to a particular facility or revolving every 7 years.

So, if a hospital appraises out at 120,000,000 (one hundred twenty million) they would be paid out 153,846.15 per week or 7,999,999 per year. This way the medical facilities around the world can be kept current and modern as time goes on. It will take 15 years to completely cover the cost of any medical establishment around the world. Now if there are any expenses that have to come to any establishment, like replacement of sidewalks or streets on said property, also if any major medical equipment, electrical, constructional, plumbing or any updating to facility or remodeling will not be paid for by the government.

There will be six different level tiers set up for the medical field. The number of people worked in each location is the classification that is set up. There will be a perk of what will be offered as for the people to perform their duties in excellence and to try to operate accordingly. You see each level tier associated with the people who work may receive an incentive bonus from Ace Services. You see each tier will monitor the complaints filed for each establishment around the world and it will work equally the same for all six level tiers or layers that I had explained.

These tiers will be monitored by Ace Services, Ace of Spades department at each county or district

throughout the world. Of each tier level, it will show a tier ranking number figured on all the locations around the world of what level achieved in each tier group they fall within. There are 3 rankings between 1-3 and 1 being the best to achieve. If your location of facility got a 1 you would fall in the top 33% with beating out two thirds of the competition with the fewer number of strikes or complaints against its location. All the facilities or medical locations around the world will be in a tier bracket that will show where they're divided up by and also how good they perform.

This will show each medical practice how well they are performing across the world and will be accessible to all in the world to be able to see each complaint against each said location. For an incentive, if you receive a 1 in your tier group you will receive 20% more of your wages or for procedures performed. If you score a 2 you will get an extra 10% of your wages or for procedures performed. And a 3 is of standard pay that is allotted by job classification that is in the Ace Services system.

Everyone will start out at a level 1 when the New World Order is activated. Let me put it into perspective for you for you can have an idea of what to expect as income for a registered nurse for instance. To qualify for the registered nurse's position in order to get paid for that job qualification you will have to have a 4-year degree or be able to pass a test of what's required for that job and that will be applied to all positions within the government. Some may require schooling and others may be simple test questions in relating to the position to be filed.

Let's say in the time before the New World Order is to be set up that a registered nurse on average around the United States makes 60,000 a year, working 8 hours a day, 5 days a week, and 50 weeks a year. This will come out to 2,000 hours for the year and will be equivalent to 30 dollars an hour. When the New World Order is in effect that same registered nurse will only have to work 6-hours a day, 5 days a week, 50 weeks a year to maintain a living. That same nurse from before was making 60,000 a year working 2,000 hours and now will start out at making 45,000 a year working 1,500 hours, but still making 30 dollars an hour. If overtime is worked it would be of an hourly rate that would be of a higher rate of pay and will be entitled to all in the world.

You may ask why only 50 weeks in a year of work. Because two weeks will be granted off or 10 working days. All whom are employed around the world can put in a request the day prior to take off for the day or up to 10 unpaid personal days a year if they want. With no refraction to affect them for doing so. All people of the world when their acceptance form is documented for whatever job that they will hold and will half to be annotated in the Ace services database.

At the time when you're at the Ace Services office, you will have to choose a listing of all holidays in the world, where you can pick 10 holidays from the list to be paid out as a 6-hour workday of your current rate of pay and will honor you time off from work for each occasion. Vacation time off from work will be allowed for all who work for the government equally the same. Starting with 10 paid vacation days a year. When you reach 10 years in any associated job within the government of Ace Services you then will be allotted 15 paid days off a year or you can cash them in at any time and work the difference. At 15 years of service, you will receive 20 days, then at 20 years, 25 days are given and at 25 years you'll receive 30 days paid off of work. No one working for the government of Ace Services will be authorized to receive more than 30 vacation days a year.

As for part time workers working for Ace Services governmental locations though out the world will receive 10 days a year paid holidays of choice even if they only work a few hours if they're considered an employee in the Ace Services database by said location of operation. No personal days will be awarded and no vacation days will be awarded to part time workers, there is an exception if any part time worker reaches 1,500 hours in a time frame of a year while employed throughout any government location. They will get the days of vacation pay that would be allotted for a full-time person. Also, by years of seniority and what is entitled to the tier ranking for that government facility. Will be authorized to receive the

earned amount of pay for vacation days which are calculated by the Ace Services system and will be paid out to any worker that achieves 1,500 hours.

Part-time workers will not receive any vacation time. For instance, a part-time worker has two different job positions within the Ace Services database system. They will be paid accordingly for what is entitled for each job worked through Ace Services. With the adjusted rate per hour of whatever job there logged in to. Two or more positions held for employment will be known as a regular fulltime job as long as they maintain a 25-hour work week between the two jobs on average. If it's at a different facility, pay will be adjusted to what you're entitled to make at that facility or job performed as well. You will not be required to work more than 40 years. If you do choose to work longer, your retirement portion of your wage will just be calculated in the last pension you receive at the age of 58.

You're able to see a standard calendar from the menu selection for each government establishment or licensed businesses authorized to operate in the world. This will be used for setting up and maintaining record of all who work for each establishment. A work roster scheduling program will be in the Ace Services database system for all government facilities and license business authorized to operate. Where any human resource personnel assigned or persons assigned from each leadership chain or licensed business to operate. Will have a list of people that work for whatever establishment with easy accessibility to set the schedule up.

Just by clicking on the list of employees assigned to each location of business, department, or government facility within the Ace Services site of any establishment while being logged in anywhere in the world. It will separate each department within a business or establishment of employees will be broken down and easily accessible with just a touch of a finger or a click of a computer mouse to whomever you want to add to the schedule in any business or government facility. Once the calendar option is selected from the login screen when accessing your employment login or to bring up the work information on any authorized device to allow anyone who is employed throughout the world. This will give you access to contact anyone in the world.

The calendar screen can be accessed several different ways. For instance, through your personal files which will be displayed in the app set up for all in the world to use to keep track of appointments and commitments you would like to list and then it will combine your work schedule together as one in your personal file to view and is contained under the Ace Services system. There will be a master chip you carry on you to allow accessibility to your phone or computer by a scanning device built in. When you scan your chip, it becomes accessible to each persons stored information that the government will hold on each person to have access to. The time the window will stay accessible for is 10 minutes at a time then at the last 30 seconds a small window will pop up that will ask you if you are still active, if you choose not to select the ok icon, it will close you out of your secure files. It will show an ok tab on the screen where all you have to do is select it to stay active for another 10 minutes and when you're done from within the system all everyone should do is just click the done button that is located on the screen. In the settings displayed on the top right of the screen, you will be able to adjust on your personal devices hooked to the system to allow more time. Or you can turn off the safe guard protection for the security of your files.

This is for everyone to have the accessibility to maintain files on themselves and for all the government facilities and businesses in the world to function accordingly. There will be a buffer built in each master chip to allow so much information to show as a constant to look up with in the system for all the people. Anyone will be able to contact anyone by writing a text message, e-mail, by phone also if you are in search of a job. For instant if you wanted to look me up. You would look on the main menu assigned to each person's individual record or job location on the site where you will go to the magnifying glass picture of an icon with a window to search in. From any business establishment in the world or the persons work site of all who are employed in the world will have accessibility.

In the work site it will show the employment of all the people that are employed through that business establishment or of government facility's and or locations divided up into departments. Where you will view all people in your establishment through the Ace Services database granting authorization to operate throughout the world. It will allow the people access to advertise in order to find employment for any individual in the world with a choice to pick what region of the world he or she would like to live and work in.

From anywhere in the world, you will be able to receive text messages and e-mail notifications as desired for any location by selecting yes or no for the locations. This will allow communications within the public or businesses around the world where they will be able to interact with the people in each community. It could be a sale from a grocery store or a dinner special at a restaurant or even if there is a time set for a bar or club for happy hour specials for the people. The people will have current information at their fingertips of what is to come about for each community around the world. Whether it is local like town or city any desired location or locations around the world, will allow you to receive notifications and e-mail to your identity.

As I say you can choose county, state, country, or world, where you would adjust what you want to receive from outside information to view in your records from within the public. This will locate any name in the world and or look up and or to see different assigned job professions by assigned number that are available in search of a job in any location throughout the world. This will show the job description of Ace Services list of jobs.

Anyone can view the list of jobs by number's associated for simple identity for the people to use. You can choose from the list, your title of any job, if you meet the qualifications for that said job you select to be known as your employment desire of profession. When you enter your search anywhere in the world, it will always show an updated and the current information on all the people. It will show a picture of the face for what the individual looks like, the address, phone number, e-mail and a number of the job description, with the description of the job assigned by Ace Services of what each person's job title will be. Which you can selected from a list of specific job classifications where it will show all the basics types of jobs for the world to be able to choose from as a profession with in the Ace Services database.

If you are unsure of what professions you may fall under, there are generic job titles to choose from like general laborer, home maker, enthusiast, entrepreneur, believer and any other job category similar, to choose or select as what you will be known for as your position of passion that you will hold with in the world. In order to hold some positions in the database you will need proof of schooling to show you're qualified to hold these assigned positions or have employment to the description of the said job to qualify for the profession name or job title to be assigned. Or from your place of employment might list you for that particular job in the list of jobs as a journeyman position until you qualify for the position. Any time you want to switch job positions or try for another job listing you will have to go to the ace of Spades department of Ace Services and have the job description changed in the database.

You will be able to list up to three different qualifications from the job list offered through Ace Service of your desired life job or desired names to be recognized from the list. That is if you qualify for the positions authorized through the Ace Services Ace of Spades department. The great thing about listing your job preference is that any time you wish to look for employment, all you must do is click on looking for job icon next to your registered number addressed to each person showing the individual basic information on the main page when accessing your Ace Services personal site. It will open up a window to have options to pick from a list also with a backup tab or arrow icon to back up to the previous list or page that was selected.

If you have more than two pages or different information to address from other files to any individual in the world like, legal authorization documents, photos, videos, or links to other sites in the world, like

Google, YouTube, this will be accessible for all to use as desired. So, on the bottom of any opened page given by Ace Services for all. Will have the same layout in order to operate accordingly or for the function to interact with Windows, Microsoft or Apple software and will show all the opened tabs with a forward or back-up arrow of an icon to select or click on at the bottom right while viewing any tab or page. This will allow you to move freely through your opened tabs on any authorized Ace Services computer or electrical device with an attenuated chip to support the ace services database with its encryption.

If you're on a laptop or desktop computer, you can use your mouse to click on desired tabs. If you're looking for a job locally, you would pick whatever counties you would like to possibly work in. You will then have the option to just select the locations of choice by clicking on the little circle or box located on the right side of every location listed in the system around the world. Whether it's a town or city, county, state or country. It will show locally the towns within 50 miles from you and if you select the state, it will list all the counties or districts in that state to choose from.

If you click on the country, it will show all the states for that country. So, if you picked the United States, it will show all the states and if you wanted to work in Florida. You would click on Florida, where it will show all the counties for Florida. Then you would click on all the counties you would like to offer your resume in to seek employment. If you wanted to work in a specific town or city you would open up the specific county tab where the town or city is located in of whatever state you choose to locate the city or town of desire. Also, if you want to look for a job anywhere in the world. You can select whatever country you choose to have your availability to work as desired if you want.

Now if you would like to look up any person or as many people searches you want to do is switch the setting on the magnifying glass icon by selecting the people search tab or button that is displayed. If you type in Scott Chally in the search window, it will show all the Scott Chally's in the world also showing the other names associated with the named individuals. There are multiple options to select if you're in your employment site as well for your personal site. The employment site will show all the people in whatever departments within an establishment as a constant of who are all employed for that establishment. All employees will have access to their department list or establishments list of all who are employed through each said business of employment."

Walter Davis: "That sounds really good for a business or anyone to look up in the system of people at their employment out there in the world. I like this system you have, let me hear more.

Scott: "If you want to look someone up from the establishment of employees, just click on the job establishments button or employee's tab located by the search window. Then select whichever department from the drop-down menu where it will show all the people that work in that department. This will show a list with different options to choose from on each person in the world. This will allow communication from all that work for these establishments around the world. So, if you type whoever you may be looking for in your chain of employment. It will show if they're associated with that business of employment.

You can view all the ones listed by just clicking on each name on the list. As for what it will show is the full name, a picture of the individual's face, the individual's phone number icon, a message icon, the individual's e-mail icon and the individual's current address. It will also show the individual's current job descriptions or desired passion of choice with the associated profession number that comes from a standard list of the people's jobs to choose from in the system for the world. Then if you select that same name again, the info on that individual will disappear and then only show the basic first and last name within the list.

Any time a person calls you on their phone, their name and number will show on a call log within the system tied to your phone network to run in harmony with one another and your able to open the basic information on everyone across all people of the world. Only the individual's own stored information

that accumulates over time in their records will be within the menu of display will be given the access to view when wanting to. Every time you bring up a list of candidates to view and if you click on the circle or box to the right of the Individual on any list. It will bring up a second window to be able to make a file if you want to and will show the person or all the people you had clicked on within the list or of multiple lists when viewing the Ace Services database.

There will be a variety of the same pattern of different buttons to select on every list that pops up to allow you to interact with anyone. So, if you start a new list or a list from your kept files in the Ace Services database to be at your access to use as like. But now let's say you need to put them in a new window or folder to keep for record and be easily accessible where there will be a command to combine the other list together as desired. Then if you select the save option it will then save your current list on file.

This will be used mostly by businesses to advertise to people through different locations of choice where they can expand their list in many ways. Also, if you would like to start a new folder on someone or contact an individual separately from the list. All you have to do is click on the name from within the list. This will open up and show a message icon button, e-mail icon button and a phone icon button that will be a standard for all as an option to select for communications to one another throughout the world. So, if you wanted to send a quick message to anyone. All you have to do is select the message icon button on the screen, where a text window will pop up where you will be able to type whatever you want. If there is no keyboard hooked to the Ace Services device, a touch screen keyboard will appear on the screen to be used. This will automatically show the person you're contacting with your contact information that's stored in the Ace Services database system and with what desired title that individual would like to hold for career occupation of choice.

This will be the standard for all individuals in the system of any attempt to communicate with anyone. All actions are monitored in the system one way or another and will show for your records to where you will be able to look back on if you want to reference. Let's say you wanted to send a picture and a YouTube video to someone. In the text window for any individual, there will be an attachment icon to select where you will have the option to search the internet. For you can have access to any site on the web. You will have access to your personal files from any device you may hold or have saved to your phone, laptop or desktop computer and all the files in connection with your chip identity of Ace Services. This will hold all the data on everyone and everything throughout the world in one large mega database system.

Your identity and all information on everyone will always be secured in the system while functioning in everyday life. You will be able to access your personal gallery of your pictures where you will be able to select and or copy and paste files and links to this text. Just like now in the world with technology you're able to do group messages to whoever. But now you will be able to contact people as you would like. It will open up to the world for personal or for professional desire of each person or establishment tied to the Ace Services system. Now you're thinking you will get spammed with messages and e-mails from around the world. But I say each person can control what they want to receive from the businesses and from the people around the world.

Any individual can individually contact anyone but if a person wants to contact all their friends at the same time with a text message or by e-mail to a birthday party on a certain day, only the people added to everyone's friends list within the system will be able to receive messages with a certainty in a mass distribution of fashion. This will be due to the fact if the individual or any individual chooses to turn off any of the areas within the Ace Services program. Which will be given accessibility to receive contact from outsiders of personal wants or needs to be addressed and for professional actions that some businesses may want to share with the public.

To not receive any messages from text or from e-mail or both text and e-mail of their discretion either locally, within 50 mile or county, state, country, and world to have the options to turned off all or any location which is accessible through Ace Services site. You are also able to go into your options to select any location or locations from around the world for either message or e-mails with acceptance to receive information of whoever or whatever to be sent or you may block. For the amount of people to be accepted for any individuals' friends list will be as many as 5,000 people.

If businesses misuse the friends list to go around the system trying to reach people that don't want to be bothered, all anyone must do is show a message stating stop sending messages or e-mail to the affiliated person or business and if that affiliation is still contacting you after you had told them not to. All you have to do is go to any post office and scan your chip in the computerized device on a table next to the people's suggestion or situation box for all the people of the world to have the accessibility to.

This device will allow you to use voice command if you like and will type out your message which you can view on the screen. When you're ok with what you have to say then you can press print, to print it out. All documentation addressed must obtain a signature for it to be acted on by Ace Services. You can fill out any action card to put in the suggestion box in any government post office. You can take a screenshot of the message how they're still contacting you or Ace Services Justifiers investigations department when solving the matter may ask for the individual to stop into the Ace of Spades department and have them open their records for them to show how the person or establishment was not respecting their wishes for not to be contacted."

Walter Davis: "Wow, just like that and action will be acted on and solved by submitting it with a signature and with showing proof. ... Would recordings work as a defense in proving cases then?"

Scott: "Yes! There will be an easy access to select on your phone of a voice recorder. This way at any time you have a situation that is suspicious or worrisome you can select to record up to 1 hour per message. If you're on the phone you can select it to record any time during the conversation without the other party knowing. And it will go into your recorded messages in your file to listen to or send to anyone. This will hold actual verification of what is at hand and is legal to post on any media outlet and hold no privacy for the public. This will make a person act reasonable on what they should say because it could be recorded. It will hold legal in court if the recording came from your encrypted phone and it will show for your identity.

Just because anyone, business or establishment choose not to remove the individual from any list sent. Which will go as a complaint against that business's performance record. Nothing can be done if you are opened up to allow the access of locations for messages and e-mails. Most people will want to have the local locations turned on in their app of notifications for events and special offers through different businesses to cast out to the local community. Any person can have the access to post in ten different counties or districts, this will also include any business with 50 employees or less.

The description of districts or counties depending on where you're at in the world will not send out more than three different e-mails to multiple people for advertising from anyone or any establishment within a 24-hour period. Text messages can be however many you wish to communicate back and forth with. You see in a text from anyone is a single file of that individual and it can go on as far as communicating with one another forever if you like. If you get text and don't like them you can hide them from view but will always be connected or intertwined to your permanent profile you establish as time goes along.

We will use counties as the standard when addressing territories at the lowest level where it contains villages, towns, and cities within. With 51 employees in any business or establishment to 499 employees. These businesses will be given access to use the e-mail to advertise within the system throughout 5

different state locations if need be and plus they can advertise to ten counties of the liking. From 500 to 999 employees will have the access to send e-mails to as many as 10 different countries. Authorization will be granted for these companies to have the capability to post. This will give them the accessibility to post locally up to 10 counties as well. 1000 employees and above will have all the world of its countries to be able to receive e-mails from these establishments. Also, any person on the planet that has a net worth of one billion dollars or more will also be entitled to post e-mails or text messages to all the countries in the world. They will also be able to send e-mails locally to up to 10 counties of liking. Through mass distribution of e-mails to be sent out. This can only be allowed in the system to accrue 3 time a day and that's for all equally the same at all levels whether its county, state, country, or world.

E-mails will have to be established for everyone in the world, this will be a priority for all the people in the world will have to have. Also, all people will have phones, which the first phone will be supplied by the government allowing you the choice of so many phones to choose from. With an authentication and encrypted chip installed for it to operate within the Ace Services system in each phone or computer device.

There will be no authorization of telebots hooked up to any phone line in the world to try to generate cliental. If a business needs to create clients or clientele it will have to be through message, e-mail or one-on-one in person on the phone. All attempts from any business or any person using a computerized telephone bots will have strikes placed against whatever business, where he or she could face fines by Ace Services for each action and if it happens to many times the business will be closed down for a short time revoking its authorization to operate. Or if it's an individual within the world causing the problem. This individual may receive jail time on multiple attempts when caught.

Not everyone will be okay with allowing their phone number and address in the system for all to see and have access to for all in the world. This way anyone can interact with anyone if they want to. I know what you fear, having easy access to a person's phone number or address. For instance, you had sold a car to someone from another location other than from your house and he or she contacts you by phone because he or she was able to look your number up through the Ace Services system from the sales slip and what is written in on the title. So, you have this heated conversation about the car breaking down on them, but when you had sold the car to the individual, it was sold for, *as is* and you had also told them it was a reliable car. You don't want to listen to the individual and you're done talking about the car situation and you feel you are not responsible for the car breaking down. So, you say, leave me alone and hang up the phone.

Later that evening the person shows up at your door and rings your doorbell, where you answer the door and feel very bothered for this individual showing up at your door. So, you have a few words towards the individual standing at your door wanting compensation for the car and you tell them you won't have nothing to do with your problem and you must leave now or I'll call the police to have you removed from my premises. The individual leaves and you assume everything's okay, so you decide you don't want to make a complaint to the Ace Services suggestion or complaint boxes that are in every post office.

The next morning you go out to your car that is parked in your driveway and notice that your car has a six-foot scratch on the side of it that looks like a key had scratched the paint. You put two and two together and realize the person from the day before probably had done the scratch so you go down to a post office and fill out and sign a complaint to the name and number of the phone of the one you believed had done the inconvenience to you. One of the justifiers from Ace Service; Ace of Spades department will contact you within a week of the submitted complaint but most likely the next day if they're not too swamped with complaints by either a message, e-mail or by phone however they feel they would like to communicate with you.

When the Ace Services five-person Justifier team collects the necessary information on the situation from both parties involved, then they will discuss and vote on the outcome and the actions that will need to be taken. In this case they would favor you for the wrong that has been done to you. Due to the fact this person was one of the last people to be around the car when the scratch had happened. Also due to his or her aggressive temper at the time when it had accrued, even though no one seen him or her do the crime it will be foreseeable on the aggressor of this simple case of this sort.

Cases of severe bodily harm or of death and cases that consist of more than ten thousand or more in theft or damages to one's property of this value will have a jury to resolve the actions taken between the parties and will be deemed right by the people of the jury.

As far as drug offences that are considered illegal will be handled by the justifiers office of certain standards to abide by when selecting the discipline for or on each matter. If there is an illegal drug dealer selling drugs that are considered to be hazardous to your health by the government it will take a 13-person jury with a judge to decide the outcome. A jury will no longer have to have all the members to agree on the case at hand to make it a hung jury of whoever. Now it will be a simple decision of vote by each member tasked for the trial to just log in to Ace Services legal law and court order section within their file and select on the law-and-order tab on the screen. Once that tab opens there will be a list or menu to access different files within the Law-and-Order site of each person. If you had a complaint it may fall under simple misdemeanor complaints on the menu or if you have traffic violations it will be under another tab within the menu or if you have a crime that requires a sentence where you have to perform time to the government will be of another example.

All active actions in the computer system will be the color red to show its still ongoing until that action has been resolved or sentence has been fulfilled. There will be no probationary time placed on anyone after any sentence served for whatever crime committed in society. There will be no refractions placed on that individual from the government, because of a crime that they had done and now have served the time for. You will know when the action turns from red to grey in your law-and-order section of your files where you will know you're a free American just like any other person out there in the world. Also, on another tab from the menu will show if you have jury duty schedule for the future. You will get a notification notice as soon as you are selected for jury duty on your main page when you log into your site and will disappear when you click on the ok icon on the pop up, on the screen. This will show all the cases you are selected for without the name of the individual that is set forth, for trial of whatever dates to appear on.

If there are no trials for the week -- (This will include local, like county, district court, state court or federal court cases to be decided by the justifiers office of the situations that are at hand for each Ace Services location within the world) -- or maybe on a couple of days for the week will only have to be fulfilled for jury duty not always making five days a week. Also, there won't be any jury duty scheduled on any country's major holidays during the year if they fall within the common five-day work week.

Until the time of the trial or 30 minutes before the start time of the trial the file at hand will be activated by the acting judge that will allow you to log in for the case at hand. There will always be a backup judge on call with the same files for them two judges located in their Law-and-Order section of their files. Where they will be able to activate commands to the 15 jurors to allow access and voting to said person or persons standing in the eyes of the court. This will allow you to see the name or names of the one or ones that are on trial but, will not give you the authorization to vote until the judge opens it up after the case has been heard in the court room.

When you are capable to vote there will be three areas to choose from but must only select one in each area. If there's more than one voting option to choose from. These cases will be set up by the justifiers office and everyone that is selected or are considered involved in deciding court cases will have the files

of the cases in their records where they will be permanent. For instance, if it was a custody case to see which parent may receive custody of each child in the relationship to select which parent will receive the right to care for their children or the jury may select 50/50 custody as an option per child. Or the jury may have an option for one of the parents to pay no more than 25% percent or up to \$500 dollars of their worked income per child of the children at hand in the relationship that's resolved by the court system. Another option could be no child cost granted for the whichever spouse that is decided on.

That would be an option if there were only 2 children in a relationship where the government will authorize each person in the relationship one child fund credit given of \$500 dollars a month. No one will have to worry or to foresee the future with having to pay outrages child support just because the individual has a lot of money or has a good job. Now in the new world the divorce settlement is entitled to be settled 50/50 if the relationship is equal in earning the same amount of income or money. So, if the woman earns 30% of the combined income, she will be entitled to receive 30% of the divorce settlement or if she had made 100% of the income or money received, on the average during the time of the relationship, she will get 100% for divorce settlement of what assets are available at hand in the relationship when its resolved.

This will not be decided by court but will be figured out by a lawyer's office to sort out money matters in a relationship of separation where there shouldn't be a problem because in your records will show all the income earned and the dates when you made the money so it's just a mathematical problem within each person's records. And if there were three in a relationship it would be divided by 33% if all the ones in the relationship, if worked equally. This will have to be comped out to where the money made by whoever is leaving the relationship has fare and just rights.

So, if he or she made 50% of the earned money in the relationship he or she would get the amount earned while being together of your joint relationships assets only that are available to clam, like cars, boats, houses, property, jewelry, tools, cash or whatever the person feels needs to be addressed by their lawyer. If there is a discrepancy within the settlement of the assets the lawyer had prepared and the other party in the relationship does not want to sign off on the divorce or separation settlement amount. It then will be decided on by the Ace Services Justifiers Department. The lawyer will have to submit the case to the justifier's office though an appointment or by sending the file of data on the individual there representing to a justifier by a call. The information will be received, and an action order will be started at that time for to be decided by the Ace Services, Ace of Spades, Justifiers Department for matters of this sort.

The proof of address in the Ace Services database system will show when whoever is living together in the same household. And all money received to any person through the government, work, pension or through someone granting you part in their estate or any money received other than the one or ones you live with will count for the percentage to receive at separation. Unless the money assets were depleted because of normal living expenses while living together. It will be of the time together and of what they had accumulated for possessions and money during the time of living together as a relationship.

It will have to be of a year living together or of marriage. And there will no longer be alimony paid to the opposite partner in a divorce. With high profile or rich people, they won't have to worry about ending a relationship and be taken to the cleaners because of a greedy partner. What I say is try and work your relationship out where you had love for in the beginning. I say no one is going to grant you favoritism, other than the government to assure you're taken care of at the bare minimum of what it cost for living within the world.

So, if you're a spouse who thinks it's going to be better to separate because of your other significant money at hand. You won't get the riches of your partner for it to hold him or her back in their life. The court system will only allow one choice to select per grouped choices to be voted on per case that is

acted on. So, if you accidentally selected the wrong one. All you will have to do is select the one you want to go with a second time and it will automatically change your selection to the correct one. When you're sure on your decision you can select the submit button within the file.

You should feel privileged that you were chosen to make the decision or decisions in court because you are a part of American justices by the people. When you log into each case you will automatically get paid after the week-long service you committed to of jury duty. The weeklong commitment may take as long as 12 hours a day but no longer than 12 hours and over time will be paid for any day past 6 hrs. All the functions for the court cases will be accessible through each person's phone. The rate for each person around the world to perform jury duty will be a standard \$30 dollars an hour for any person. When you're randomly called from the computer of Ace Services to appear in court you must commit to the commitment of showing up and participating as a jury in the understanding your opinion will stand whether you agree or don't agree with the one on trial.

There will be 15 people assigned each week to show up for court as court is to be held. The only way to get out of the assigned jury duty, is where you can't possibly miss a life treating procedure or of a death of a loved one like parents, siblings, aunts and uncles, nieces and nephews, cousins and grandparents will grant and excuse for the day of funeral and if it's a near friend that had passed; you must put in a request to take off from jury duty for the day of the funeral that can't be rescheduled. A doctor's note will be needed for the individual's said situation or on the day you're scheduled to appear as juror you become sick. You will have one freebee time given as ok but if you miss a second day without a doctor's excuse for jury you will be put back on the top of the selection list for jury that is if you don't commit to your assigned days during the trials of the week.

So, you're able to miss one day with nothing done. More than one day you will have to show each day missed with proof of documentation of said sickness will have to be annotated in that individuals medical record to show as proof to the acting judge. You can have a note written out by a doctor and will have to be presented to the judge in order to release your excuse in the system for no other consequences to come to you. You will have one week from the Friday of the last day of jury for the week to be able to show an excuse or you will get a weekend in jail that you will have to commit to for your action that you had failed to commit to.

If a doctor signs off of why you couldn't make the appointed jury trials, this will be accepted. So, if you're sick and miss more than one day, you have to get a doctor's note to bring in to the appointed Ace Services; Ace of Spades office within one week of missed trial duty. Or you can present it to the judge to release you from other commitment. Or have the excuse documented in your medical so a justifier can open it up at the Ace Services office to cover you reasoning of why you missed. If not, you will be ordered to serve one weekend in jail or 48 hours. For this fact of interrupting a government trial of business that may cause the legal system or courts to reschedule the cases if the people don't show.

So, yes, I feel if a person wishes to skip out on their commitment to society, they should have consequences to endure, and I feel two days on a weekend should justify the discipline to be given and plus I want the individual that skips the jury duty to be placed back on top of the jury duty list for the next section of candidates. No one should have to do Jury duty more than one time every seven years unless they fail their first commitment. The age for the selection of jury duty will be from the age of 25 to 65 years of age. If you're crippled up where you can't get around appropriately or have a disability where it affects your everyday life, it must be annotated in your medical records and there will be a yes or no marked in your medical files to allow it to show in the system to allow the selection of people who are able to perform jury duty.

Also, anyone who submits or places time off of their vacation days on their work calendar in the Ace Services system will not be selected for jury duty during their time they or you take off as long as it is

annotated 30 days or more in the system. So, I say stand tall and be an American and do your commitment in society if called upon. You will see the order of the case that is at hand in your file and you can look at and act on the document of judgment on the said court hearing. There will be options that come available and will open up to you after the judge in charge of listening, verifying that the evidence is shared to both parties, directing fair legal presentations from both parties to be fair within the law. The judge will go into his or her file when he or she is ready for what will be decided by the jury and select an action button or tab to be selected to allow the 13 to 15 members the ability to cast their vote for or against defendant on whatever said trial at that time.

Only the judge of the trial will be able to see all the results of each person's decision on the trial. The judge will call the court to session again and read out the 13 votes that he has in his file. As he or she says juror number 1 voted for 7 years, juror number 2 voted for half a sentence or 3 1/2 years and juror number 3 voted for to be set free on the voting ballot in the system and so on until all 13 votes are accounted for. We will say that after the judge read out the votes and that they were tied with the same number of votes for 7-year sentence and 3 1/2-year sentence, so the judge looks on his phone or computer screen and reads out the 14th juror vote to come up with a majority vote to close a case.

If two jury members didn't show to court, there would be only 13 jury members total to make the decision in court. This would have been a good jury trial but will not be decided on for actions to receive if the votes don't show one of the 3 sections as a majority. The judge will enact or sentence what was decided by the court for the crime by set laws with standard set justice or prison sentences to abide by within the government. Each case is set up by Ace Service justifiers department ahead of time, so when the party is found guilty, he or she will know what the disciplinary actions could or will be. Certain high-profile cases may need a jury, also large divorce settlements may need a jury for each individual or individuals who fall in these categories I listed. Certain sexual assault cases will have to appear in front of a jury, which will be decided on by the justifiers location of where the complaint had come in.

The justifiers will make all decisions on how all complaints will be handled by a standardized spreadsheet listing of common actions for whatever offences are done within the public that are not considered appropriate in society. Cases that fall within the guidelines or of similar cases will be the standard for what penalties or discipline may be addressed for each case that comes to them. The justifiers will make all decisions on each matter. Whether it's assigning a disciplinary class to attend in order to watch a video or assigning community service or giving an assigned prison or jail sentence or preferring the one that is facing the matter of what's at hand to be decided by jury.

You see, the justifiers will handle all simple complaints to be decided on from the public. Like if a person had made a purchase or had a service done by another person or business. If the service wasn't acceptable for what was decided when you agreed for the service or if a product that wasn't received.

We will use an example of a service from a local contractor that did a remodeling job for someone. A week later the person or homeowner that had the remodeling done sees in the living room ceiling what looks like a water leak and it's covering a 6-foot area in the ceiling. You call the one that remodeled a couple of bedrooms upstairs and remodeled the upstairs bathroom and they were paid for a job well done and accepted by the owner but, now a week later you have a situation of a water leak and want it fixed or taken care of by the one that did the service. The contractor tells the homeowner that his service was fulfilled and there is nothing that will be done.

So, the homeowner goes to the post office to a computerized communication hub and scans his or her assigned identity chip to the device and types out a complaint with addressing the name of the business, the contractors name and a brief statement stating the situation, then it's printed and signed. Then it's placed in the complaints and suggestions box. The next day one of the Ace Services Justifiers contact you by message saying if you can take pictures of the water damage and send them to their number and

then tell them if they haven't already, to get a plumber to fix the leak and send a copy of the repair to the same number and patiently stand by until we figure out what needs to be done.

Since there was a problem within the first 3 months or 84 days after the service has been done the contractor or the one that provided the service has to guarantee their work or service by government standards. The Ace Services justifiers office calls the contractor and explained that he or she has to stand behind their work that they administer through their business for a minimum of 3 months by government standards. The two different justifier teams of 5 people each will all be annotated in the system for every order drawn up and the five panel justifiers team will have the protocol of disciplinary actions or to resolve each situation that is presented to them.

When an action is to be addressed there will be a standard set form placed in the person's records under Law and Order which will be permanent for the record. This will also show for a business and will stay active in the Ace Services; Ace of Spades; justifiers office for every situation that comes to them with all 5 justifiers on the corrections order form of what is generated for each person who has a situation. Ace services; Justifiers Department had decided for the damage or problem be taken care of within 3 months and had it addressed it in each parties' records under Simple Complaints in Law and Order with a pop-up message on the persons main page when logged in, to let the individual know. Any action that is written up with all parties involved will have an action sheet added to their records to show whatever action pending in red.

There is a double check system where there will be another team of 5 justifiers to decide for the same matter that was decided for justice to be performed. The second team won't know what the actions were decided from the first team of justifiers but, will have all the notes and research info and data for each case.

Now back to the car scratch, the local Justifiers would contact and order the individual that came to the door and had harassed you to pay for the damage done to the car and would have two charges placed against him or her. For one this will be considered unintentional stalking and the damage to the property will be another crime and that is considered assault since it was directed towards you. The discipline for the first charge of unintentional stalking through Ace Services will have the individual with the offence come in to the Ace Services Ace of Spades department with in the county to watch an hour-long video. On the matter of unintentional stalking on why and the different situations that are considered wrong to do within the society.

The video will tell of other offences of the same in nature and how it will affect the individual for increased discipline for each situation as if it shall happen again. Also, you will have to pass a test over the video with a 70% or better. If you don't pass the test you will have to come back another day to watch and take the test over and over until you have a passing grade. You will only have one month (28 days) to react to the time of receiving the notification to fulfill your commitment to watch the assigned video or videos for simple misdemeanors within the government. If you choose not to serve your commitment in the time allotted the police will locate you wherever you are and place you in jail for two days with no excuses for getting out of it. But at least you won't have to watch the video if you do the time.

If you're unable to read or comprehend the test, you may be tasked to watch another four videos decided by the Ace Services justifiers. It will be up to the justifiers for each person's commitment to be served. On the second offence of assault where it's a little more serious where the individual will learn about and watch an hour-long video on what is considered as an assault and why it's not tolerated in our society along with what will happen if you shall get a second and or third offence of the same in nature. He or she will have to pass a test over the video. And the second added discipline to be granted and decided by the justifiers for the act of doing damage to one's property in the attempt of acting out revenge is to

serve 100 paid hours at \$10 dollars and hour of community service within 16 weekends with a start date and location to show up at.

Community service may consist of mowing or weedeating grass, either by a riding lawn mower, push mower, sweeping, gardening, collecting trash, painting, gathering branches and of any job that does not need technical knowledge or a degree. What the community workers that are ordered to serve will not be required to do, even if they're qualified, is to do technical work like electrical, construction, plumbing, mechanical, secretarial or be able to drive any vehicle that requires a license. You may say why wasn't the person charged with vandalism versus assault. It's because he had the charge of unintentional stalking that shows his anger and the damage show an act of violence which is also an assault towards that person.

All disciplinary actions to be fulfilled must be logged in to the Ace Services database under corrections of your law-and-order record. There will be a log in button that will monitor any activity done for whatever is to be performed. like watching videos or serving community service hours. There will be a page in a file of your site that will show what is directed to be performed by law by any participant of creative actions and this will be found in the Law-and-Order section of each individual's site. There will be a log in button to select for each different discipline procedure to be completed. So, for watching a video addressed from Ace Services justifiers department you will automatically get paid 2 hrs. for the class of, \$10 dollars an hour. If you were to watch a video on sexual harassment you would log into the site and go to the law-and-order section and click in and find the description of the topic which will be listed and log in by selecting the log in button. Then you can watch the video and you can take the test and achieved a 70% you are then granted free of commitments from the government when all actions are performed on the action pending in red turns to gray in your records that are set up by the justifiers.

When the action in your file changes from red to gray it means there is no more to worry about and the actions because they have been resolved. You forgot to sign out after taking the test but within the system there will be a timer set for announcements to automatically log you out of the system after two hours. Now this person that supposedly placed a long scratch on your car where you used the Ace Services actions of disputes and suggestions service that is available to all in the world. You assume your situation was handled and taken care of by the justifiers of Ace Services; Ace of Spades department.

The guy is irate about the whole situation, and he feels the only way he can find justice is to go back to the place of the one who sold him the car and settle his problem with them. Now he's at the door of the one who turned him in to the law and bangs on the door. The owner comes to the door and starts to open the door and the guy pushes the door open and the homeowner falls from the sudden push and then gets up right away and see the guy pull a revolver out from behind his back. The homeowner runs to their bedroom in the house through the kitchen and closes the door to the bedroom and go to a night stand and gets a 9-millimeter hand gun and then threatens the person from the other side of the door that you have a gun and will use it if you don't leave.

The guy ignores what was said and breaks the bedroom door down and at that time the homeowner has the right to shoot the individual anywhere from the waist and lower on the body but are not authorized to kill the individual due to the fact he or she did not fire their weapon. If the person had opened fire, you would have the right to kill the individual for self-defense and you will be clear of murder because it was an act of defense.

Now you're saying what if I don't have a weapon and this happens. Well let's say the homeowner has their phone with them and then runs to the basement where they have a metal door for a wine cellar and now, are inside the wine cellar room with the door locked. All you have to do is on your screen of your phone there is an option of fingerprint identification and all you have to do is hold your thumb or figure print for 7 seconds and there will be an alarm or loud siren type noise and you can authorize it with voice command or by answering the question at hand on the phone that says 'Is this an emergency?' where

you say yes or select yes. If you accidentally activated the alarm all you would have to do is select no or say 'No, this is not an emergency!' and nothing will happen. Only answering the question with a 'Yes' will activate the system automatically. One ambulance crew, a police officer and a fire truck crew to the scene. This will all happen by using triangulation of your phone where you're located on earth by cell towers and satellites to know where your location is at with the nearest address. The action from the person's activating the help action on the phone that is presented.

This will be easily accessible because all three response teams are activated on any emergency at hand. Also having a list to all that are responded by the Ace Services system of local where it will show a contact name and number to know who's with each responds team. Realize after the alert comes in the paramedic passenger can try and call the number that's shows for the emergency on the display in the vehicle to find out what to expect when they show up and maybe call for more help to the seen. Now you hope your metal door is strong enough to keep the intruder out till the police show. But let just say this intruder doesn't have a gun and you do. You're not authorized to kill the individual even if he or she is on your property but will be decided by court if the homeowner shoots the individual in the leg because you were fearful for the individual that is coming at you on your property while telling the individual to leave or stop. If you shoot someone on your property and they don't have a weapon you may be subject to what the court feels is adequate for the crime done. It could be a 20-year sentence if a life is taken, or 7 years if you shoot and wounded, this will be an assault on the victim and if you can't prove your case in front of a jury you may get 7 years for causing harm or action of harm on the trespasser when there are other ways to handle the situation.

But, just like celebrities and famous people out there in the world will have their main phone contact line for the people of the world to use if like. People may want to invest in a second line for privacy. So, for this reason if anyone feels they need to get a second line to use within the Ace Services system they will be authorized to do so. It will function accordingly within the Ace Services system by keeping track of all operating data of the second line as well. The number will be added to your chip identity in your files to be assigned to each person that wishes to have a second line in the world. No one will know your new number unless you call that individual from the phone or give him or her your number where it will be kept from the public access to view. Or you can have it where the numbers won't show for the phone number but still list the name of the caller for security purposes, but within the system of Ace Services; will be able to access your number if need be so it will have to be added to the Ace Services database.

One thing I would like to mention is that you will not have to log in to any site with a password anymore. Your chip will be encrypted to where only that individual can have access to any site with security of the individual's information in the completion of the World Order. All separate websites that require access to will be able to adapt to the new system for all. So, Facebook, Instagram, Twitter, YouTube, Amazon, PayPal, Venmo and any other established site that may retain information on you. All the people of the world will have to do is in the Ace Services personal home page, that all will be granted for access to their files because of the master chip they hold to allow access. On your main page after you authorized your access in the system you may place whatever apps you would like to have for your accessibility to interact within the world however the individual wishes. Within the menu you select will have an authorized listing of all apps that may be selected.

Any sites that are not in the Ace Services system but are accessed through the internet of an unsecured line will not affect your files of encryption, but it will be considered not secure on the credibility by why it is not authorized to operate by government standards.

Now back to the topic of retrieving a job through Ace Services site for all the people of the world. Anyone will be able to post for a job anywhere in the world for any job classification their qualified for or position to be offered with the acceptance of the employer to allow for the individual to be trained for the position. Realize everyone will have a standard resume template to use within their files in the

Ace Services database that can be changed or filled out to the likening of each person as time goes on. When you post looking for a job, your resume, listing of your history of employment or schools of training, education, academic and achievements recorded. This will be all available to view from any interested employer looking for a candidate to fill their position.

There will be authorization given to each business establishment to allow a human resource personnel or so many people to have authorization to view education, academic, achievement records, and of previous employment or current employment. Also, of schooling attained in their records for hiring people through the Ace Services system. This will include anytime anyone does any type of corrections that's longer than a week long, like serving time in a facility set forth by the government in law. This will show your attendance in life for each career choice attended and worked in a revolving record that will always be current.

If a person is offered work in, or from any government correction facility, jail, or prison. They will only be entitled to make \$10 dollars an hour according to the new world standard, where the minimum of what pay will be. And that will be not less than \$10 dollars an hour. Also, if the person that is in a corrections facility chose to work, it will also show up in their employment window of their records and will show a revolving record of what you or they have done for work and what your retirement has accumulated for a balance over time. There will be a correction facilities general work number allotted to address all the different jobs through the government correction facilities or departments of corrections for the people that fall with in this category. This will be the world standard of paying out all who are doing time for their actions of 10 dollars an hour whenever logged in to the system for work. Once a court has sentenced whoever to time, they will have to serve it in part of the process of the courts to annotate the time from starting date. Till all of the time of the sentence has been fulfilled. Each person will be kept track of through the Ace Services Ace of Spades department.

All that are active doing sentences from around the world will have a standard job rate of pay of \$10 dollars an hour. All will be authorized for any person doing whatever form any corrections facility at the facilities at the officers' desecration with who will do whatever, if it allows jobs to be worked.

The common structure of some of the basic crimes I will list are for instance if a person is charged with a death of another. The max sentence, penalty or jail time for any single death charge will not be more than 20 years to serve in prison or of total jail time of the offence. If it is a double homicide, they may get up to 40 years and if there were a third victim that was killed that person will never step foot back out into society ever again and will have to serve a life sentence in prison until they're bedridden. This is when they then may go to a care facility.

There will no longer be a death penalty in the new world. When these death cases go to court there will be three options for the jury to select from, one will be 20 years sentence the next option will say 10-year sentence and the 3rd option would be: I feel the crime warrants no corrections and feel the individual should be set free. If a person is an accessory to murder their max sentence would be 10 years and would stand in the same trial to make the decision by the jury.

The next crime I will state is meth or crystal meth and of drugs of this sort will be a 7-year sentence if you have more than 3.5 grams in your possession where a jury will decide your fate. On a second offence the penalty may be double or 14 years you could be facing by the law of the people. And if you had received a 3rd charge of having meth in your possession of 3.5 grams, you could get up to a 20 years sentence as that individual will be considered as a dealer. Meth destroys the mental ability to function accordingly in society that allows a person to act out irrationally.

On rape cases it must show a struggle from the one who says they were raped or under the age of 15 years of age without the consent of the parents of said child. Rape charge will receive 14 years for a max

sentence of a 1st time offence decided by the jury. 2nd offence or if that person raped multiple women, they will get up to 20 years. The 3rd different offence addressed to court could send the rapist away in prison for life. There will be a statute of limitations on any suspected rape or sexual assault cases of no longer than 7 years for it to be acted on and will hold no crime if it comes up after the 7 years of its supposed occurrence. In most cases of rape to be proven it must be within the first 24 to 48 hours to prove any rape to see the body marks, semen or DNA samples on the victim but, should be acted on immediately.

Now for sexual harassment and sexual assault if there is no sexual penetration, the sexual harassment and sexual assault will be handled by videos to understand what you can or can't do in the situations of sexual assault cases by the justifier's office. Some sexual assault cases may have community service to commit to for a short while. If sexual harassment or assault happens three different times within seven years that has been addressed to the justifiers office that person will have to automatically do one year in prison for three different occasions reported as the fault.

If anyone duplicates anyone's identity in any media chatroom or site or through text, like a celebrity or any other person on the planet to either portray someone other than themselves, destroys one's identity or to try to scam the public for money of another person's identity will automatically get a year in prison for doing so. If written consent is given, this will be legal tender for proof as long as it's signed by the one allowing their identity to be used. Make sure if you don't want your identity scammed by the one you granted the accessibility to use your name for what you will address in the approval letter and to stop scams under your authorization. All you will have to say is, No-Scams. So, if the person does any proven scams that you did not authorize, he or she will be subject to time serve if found guilty by a jury of not more than a year per case.

There will be a signature icon displayed in the window of your Ace Services file where all you would have to do is click on the icon and select where you would like to apply it on the screen. Then a signature window will be displayed. Then you may use your finger or a stylist to draw your signature. There may be different stored signatures of preference for your file. This will also show your identity within the Ace Services system for each person's encryption. This will also show the different for say if you had shared an e-mail address to know who's who.

For Assault to someone that causes bodily harm, to an individual better hope that individual don't sustain a medical board disability because of the injuries from the assault. Because they may face 5 years in prison doing the harm from a jury. As well may have their wages garnished for life to pay the victim of a medical condition they had caused. The action at the justifier's office will put the file on hold till after medical proceedings are finished in one year, give or take a month.

Basic assault cases will be handled by the justifiers standard layout of procedures to operate by. Theft will consist of 1st to 5th degree for a charge. 5th degree will be of miscellaneous theft of \$10 dollars or less, 4th degree theft will be of \$10.01 dollars to 100 dollars in theft, 3rd degree theft will be from \$100.01 dollars to \$500 dollars in a proven theft attempt. 2nd degree theft will consist of \$500.01 to \$10,000 dollars in theft and 1st degree theft will consist of \$10,000.01 dollars and up.

For 5th degree theft you will have to watch a video for the first offence that is about 1 hour long. And if it was your child is under 18 years of age, both parents will be required to watch the video. Also, if a child is under the age of 12 years old the parent will also receive the charge under their record in the system showing the child's name that did the crime. If you're the parent you should monitor everything that your child does and if they commit a crime under the age of 12 you will have to pay for the consequences of your child. At the age of 13 years old the child will conform with the adult public law on all crimes committed. The justifiers will put whatever action pending in each person's files of Ace Services that needs to fulfil a commitment.

4th degree theft will get you community service and a video to watch. 3rd degree theft will get you double the community service for every weekend for 6 months to a year, plus you will have to watch a video as well. 2nd degree theft will put you in front of a jury with a max of a 3-year sentence if found guilty. 1st degree will give you a sentence of 10 years unless the amount of the theft was over 1 million dollars then the max sentence could be as much as 20 years.

The new laws for the people will be effective immediately after the people instate me as leader of the world. All the people in prison will have to see if they have met the requirement of served time compared to the new standards to see if they can be set free. All marijuana crimes or charges and also all cocaine crimes or charges against anyone sitting in prison or jail will be set free also anyone who holds only a gathering charge will be set free. And for all the ones released from prison, I want the governments of the world to immediately pay the ex-convicts a minimum of 1,500 dollars in each country's currency to be paid monthly until the new world order is up and running in January 2027. One last request is to release all the prisoners of war throughout the world and that includes all terrorist."

Walter Davis: "Terrorist! Isn't that extreme?"

Scott: "Not really Walter; there will be no need to rise up against anyone due to fair and equal justice that will be for all the world. When you look at the law officers, they will have the right to write any ticket by law and you will have to pay it without taking it to court. You may pay the ticket at the time you received it. All tickets will be official when written up by a law officer. You can contest any ticket to the justifiers office if you feel it wasn't fair Justice.

Drug testing from businesses and establishments will not happen anymore. This is unfair for the workers not to be able to choose to use drugs on their recreational or personal time. No drugs should be used during any working hours across the world unless authorized by the employer. Anyone who takes drugs have a little bit of a different effect how they can work and communicate.

So, for the new standard, I will make a three-check test for sobriety to be administered at any time. This can be done by any officer or any manager that feels an individual is inadequate where they may challenge the individual to do a sobriety test before any actions can be taken. The testing will consist of walking a 20-foot straight line. If the individual did fine on the walking, then you may have them to recite the alphabet. If the person did fine on the alphabet, then they will have to count backwards from 100. All who pass this test is fine to work and no further testing will be done on the individual and it will be case closed.

Now if a person fails any one of the three tests administered, they must be sent home from work. The employee can be written up for the occurrence and if they receive two write ups before the third time within a year. Then the employer will have full rights to fire that individual. On a third time being intoxicated or on drugs the employer will request for you to take a uranalysis test immediately to see if any drugs are in your system and if you show up with any drugs in your system that will show it as your fault. The employer would have full right to fire the individual and the individual would have no right to defend himself. Unless a manager didn't like you and lied about not being capable to perform your job and falsely sent you home when you had past the sobriety test given.

What I would say to this is stop it before it goes to a second attempt to send you home from work, where you will have to gather the witnesses which watch you do the sobriety test and make a complaint to Ace Services. The justifiers will look in to all wittiness reported and the one that sent you home to see if there is any malpractice. If the manager is at fault, he or she will get a strike against his or her performance record as well for the whole chain of command. On that first line leader, he or she can't receive more than three complaints of fault, against their performance record in a three-year time frame.

Same way as if an officer of the law who pulls you over and believes you're incapable to drive but if you pass all three areas of the sobriety test, the officer must let you go. Certain high-profile jobs will have to be monitored with a drug test like airline pilots and surgical doctors. If an accident occurs during work, a blood test can be requested if the employer feels it's necessary.

Guns will be authorized for people to carry on them in public as long as it's not an assault weapon, across the world. All people will have to be authorized through Ace Services to own weapons. If anyone has an assault charge on their criminal record, they will not be authorized to own any weapons until seven years have passed from your last offence and then depending on the assault you may or may not be authorized to own weapons again. The people with their weapons will not be authorized to bring them inside of schools, banks, courthouses, hospitals, public transportation or airline transportation. When you go to the airport, they will have you check in your fire arm in order to get on the flight.

The age allowed to carry will be opened at 18 years. For hunting, a youth can start at the age of 13 accompanied by an adult. A standard fishing license will be required at 18 years old and a set standard of 25 dollars a year to fish anywhere across the world. Hunting licenses will be set at 50 dollars a year to all controlled gaming by the DNR (Department of Natural Resources) across the world. In order to get a fishing or hunting license you will have to go into the Ace Services Ace of Spades department and watch a one-hour video and take a test. You will only be required to do this once in a life.

At the age of 18 that is when a child becomes an adult where they will have all the rights as all their other superiors in life. They will be able to buy alcohol, tobacco, drugs and be able to carry a firearm.

Now, as far as smoking in the world, it will have to be adopted into our society as equal for all. So, I say we will have all public places to have both smoking and non-smoking available to the public. Airlines will have to offer smoking on their flights on any flight over two hours. Now we live like we do because of some of these prissy people out there in the world that only think for themselves and not for what's fair for others. I say if you're a nonsmoker, you walk away from the smoke if you don't like it. All drinking establishments around the world now can have smoking indoors. The businesses will maybe have to put better ventilation systems in their establishments.

Fraud will be of another that all people and businesses will have to abide by. For instance, if a business offers an ability to grant a commitment, sale or a promotion to the customer or client for doing a service or addressed deed for the costumer of whatever it may be. It must be completed as its written up by said date to be done by or not longer than a year. If an establishment falsely makes a client to be looked at as being wrongfully casted out to look bad from there services rendered, also due to a third party in like say a bribe to affect the party that there representing that will also be considered as fraud. If that business or person that had received the money did not complete or stand by what they had addressed to the client, they could face jail time from court if found at fault.

This will affect all people in whatever establishments and businesses around the world to always try to do the right thing for the costumers or clients that they may have. If a person working for the establishment is pressured in doing something illegal, they may come forth to Ace Services to get immunity for such crime before it is acted on by the law otherwise all parties involved will have the court to decide the discipline for them. The crime will be decided by court with a jury to decide on all fraud cases at hand by choices they may pick. The choices for the jury will be either 1 month in jail, or 6 months in jail, or 1 year in jail, or 3 years in jail, or 7 years in jail, or 10 years in jail, or 20 years in jail, or no significant findings to warrant jail time. This will be for all parties involved from each establishment being individually sentenced from each trial for each occurrence.

If there is any company or establishment that deals with the people that has more than 5,000 followers to their site may be taken over by the government to regulate and run for the future decided by the court.

This is for the people's sake if the establishment is not conforming to the government standards where the owners will no longer have any control of their site anywhere in the world. They will get revenue from the site of whatever the government makes from it after paying out what it takes to govern the site. This includes any social media site or product sites. Remember the 1st amendment freedom of speech must be for all in the world. Some of these policies I had listed will be effective immediately or when the New World Order is set up in 2027.

Now, I will continue with how easy it is to try and get a job in the new world system of Ace Services; So, for example a person's job on the Ace Services site will be listed for job classification as a general laborer. That job number in the system let's say is listed as 1,389 for that job recognition number on the list. Now let's say a local factory was looking for some assembly positions to be filled. The human resource personnel will have the access to look for employment to fill any position of need at their fingertips behind the Ace Services site. In the work screen for all license businesses to use where there is an icon next to the looking for job on the top of the home page next to the search window. This will be used by authorized people in the system to have the accessibility to use to find or locate people for employment for any establishment.

If you do not have authorization to search for employees, you will not be able to use this icon. The human resource personnel when on the site will click on or select the icon designated to find employment and we will call this icon Job Availability. After clicking on the Job Availability icon there will be a small window that will pop up allowing you to request locations from a listing of icon commands from the small window of counties, state and countries you may choose to look as desired in order to fulfill your needs for employment. Understand that your place of business or where you're established will be the constant for when you selected county or the appropriate state and country, you're in. So, if you select the county, it will show the list of counties for that state you're located in with your county on top of the list. And just like state it will bring all the states up for the country you're in, where all you will have to do for the search is select the little circles next to the appropriate states you would like to look for as candidates for whatever classifications that is needed to be filled.

The small circles to select on the right side of the counties, states, countries will be for all authorized personnel to be able to use for their selection within the Ace Services program. In order to find the candidates from around the world you will have to enter the job classification or classifications of liking for instance if you're looking to fill a position that has to have certain qualification you would pick the precise job numbered from all the jobs listed for the world. Also, when that window pops up it will also give you an icon to select from the jobs list for you can look up what jobs you need for the search engine inside the Ace Services database system. When selecting the job list from within this pop-up window it will show a complete list of all jobs in the world. If you do not wish to scroll through looking for the proper job description you can type in the window given and it will show the list from whatever you have typed for a job within the list. Of course, the list will be broken up in sections, like listing all the positions of what classifications you would like to pick that doesn't require schooling beyond 12 grade, then medical jobs, then construction jobs, then government jobs, then technical jobs, then trademark jobs and so forth to make easier to scan through all to different types of jobs. The list will show the categories in alphabetical order and inside of each category will be in alphabetical order.

The list of jobs may be 500 numbers allotted for accessibility in the medical field. There may only be 150 different types of jobs within the list. This is for if there are new jobs classifications to be added. One thing for sure is that the number given for whatever job when established in the Ace Services system will always stay the same, but if new jobs are added to the list. The new jobs will just be placed at the bottom of the category that it will fall within and will be in sequence with the numbers but not alphabetically. Unless you search alphabetically.

Now if the human resource personnel or authorized person was tasked to find more help for the

business or factory. He or she will go to the employer site and select Job Availability icon and types in the job number that is allotted in the window on the site for jobs. In an example we will use 1,389 as a general laborer for classification needed. After the number has been entered you can select the location or multiple locations in search for people that may want to work for you. This will bring up all who are available in whatever search you do. And this brings up another window of a list of availability to fill whatever position. The ones that have access to looking for jobs can click on or select each person on the list and it will open up like any other person you would click on within the system where you will have a small circle to select if you would like, for you can save whatever individual to another list for your records.

Also, this time when the authorized person opens the basic information up on a person from this search list will show two extra icons to choose from. One will be an icon to bring up the selected individual's resume. It will show inside the resume skill qualifications filled out by the one in search for the job. As far as the jobs worked will be kept current with updated information on what jobs were worked and dates that were worked from each individual and will automatically be kept track of as time revolves for each person's record. It will be current and correct on all but won't show the income from previous jobs worked to the potential hirer. It will only show a record of employment or time fulfilled for each adventure in life.

It may take many pages to explain your resume to your liking. So, there will be an extension of the resume page to where you will be able to scroll up or down on it to view for it can grow to handle whatever needs to be addressed for each person's skills or abilities. This will automatically add to the page to show for each person within the system. The second extra icon is to view the education, academic and achievements that are on file of the one who is seeking employment. Once you select the education icon it will list all the schooling on that individual from the oldest to current where it will allow you to scroll up or down to be able to view all the diplomas, certificates of schooling and education of grade school, middle school, high school, trade schools of certifications certificates, college and any schooling of learning can and will be added as desired. Unless that individual doesn't want to have miscellaneous schooling in their file which would have to be added or taken out at the Ace of Spades department.

All test for each year of schooling and all progress tests will be permanent in all records. On the top of the education page will give you a choice to open up two other areas, one of Academic icon to show different sports and activities that had been committed too. The last one is of Achievement icon for achievements and awards achieved in life. This would also show any titles held while in competition, like sports, educational contest, hobbies, awards and certificates of achievements on each person that applies for employment. If you would like to pull multiple employment listings at once. All you have to do is place in the window for what the job number is and connect all the job search numbers in sequence with a dash to separate them job numbers, for example is 1,389-236-2,190-603. For whatever you pull up the search for it will list everyone looking for job with the qualifications you had entered to be combined in to one listing for your records if saved. And this list can be kept where you can eliminate the ones from the list just by clicking the circle that was shaded in when it was selected but now when you click on it again it will disappear from the list. And each page listing pulled up will give and option to combine the list to other files or lists when you select that option.

The authorized people from each establishment in the world will be able to search for jobs in the Ace Services system to see all that is available. They can look through all the candidates looking for employment and can choose who they want to contact through message, e-mail, mail or they can call them to set up arrangements to meet. Or they can set up an interview time to be contacted by phone or providing information about the employer.

There will be a 28-day month calendar allotted for the future for all the people of the world for the days in a month except December will have 29 days and there will be 13 months in a year to equal 365 days

a year for when the Ace Services world order is up and working. Also, every four years in December there will be one extra day added to the yearly calendar to keep the seasons in line. So, December will have 30 calendar days every four years or considered leap year and the days of the week will always stay in order with Monday being the first day of the week and never any skipped days, for the Sundays are always to be true for the people respect this day in holiness.

Midnight of the start of the first day of the week Monday or after Sunday night will be reset to new hours for each day for it to correct the celestial timing of gods holy system or holy city in heaven of how it revolves each day. So, if it was midnight on a Sunday or the beginning of Monday it will be moved two hours back to 10 PM Sunday night or the new time will show midnight or 12 AM Monday morning. If you're used to eating at 12 PM and 6 PM for your main meals, now you may consider eating at 10 AM or 4 PM of the new standards for time in a day. Realize in the morning if it gets light at 6 AM it will now be 4 AM when it will be light out for the new time.

There will be an overlay of the previous calendar where the days will be marked accordingly with the new days that fall within the old calendar to see what your special occasions will fall on, like birthdays and anniversaries.

Now back to what a registered nurse will be doing in this new world. I figured on assumption and research that a registered nurse figured from working in the United States will make on average \$45,000 a year working the new standards of 6 hours a day, 5 days a week, for 1500 hours a year and 30 dollars an hour for starting. Now figure a registered nurse will need a bachelor's degree and that will take about four years of the individual's life to complete. We will say the individual starts college right after finishing up high school at 18. Their age to commit to working would be 22 after completion of the schooling. When the nurse finds their job at one of the medical facilities around the world where the job is established at a certain rate of pay in the Ace Services database will automatically pay equally the same throughout the world for each position worked for the government.

All jobs will be established for the rate of pay from the average from across the United States of the same jobs for rate of pay. After the World Order goes into effect you could search in Germany for the same job within the government if you like. This job will be the same pay from anywhere in the world. There will be a percentage rate of (0.0205959100%) added to the wages of the next revolving year of whatever job position held by the government workers. For instance, I will use numbers that I had already went through and calculated out for 39 years of working in the government of what you would make as a nurse or a doctor as an example to be based off of.

There are 24 pages you can look at that show the comps for 39 years of work if you desire to work that long. You will get your second pension at the age of 58. If the person feels like retiring at that time, they may do so with ease of knowing you will get a pension for life. In the new world you're only required to work 30-hour weeks and 6-hour days. There will not be incentive for working a second, third or fourth shifts. All shifts and weekend duty's will be of regular pay unless you work past your 6 hours for any day working or past 30 hours for a 5-day week.

The calculations are of three different tiers that would get paid out at a glance throughout the medical field. And what will be granted for all government workers but is only tiered in the medical field as an incentive. A nurse will make \$45,000 a year working 1,500 hours in a tier 3 establishment in this example where he or she will be making \$90,000 a year after the 34th year of work. When you started as a registered nurse it was \$30 an hour and after the 34th year you will be making \$60 an hour. That's when it caps out of double for your wages from when you had started. It will work equally the same for all the people that are employed through the government. I used for this example of the cost of living for a population size of 150,000 to 200,000 people for what you would get paid through the government to just survive off of. That would be about \$2,600 to live off of per month and that would equal to \$33,800 a year to

be added to what you would make for the month or year to your income.

So, if you were single without kids, you would be making \$78,800 a year as a registered nurse for your first year. Let's say for this next example your around 40 years of age and you have been working for about 18 to 19 years for a tier 1 establishment and have your 1st pension coming in every month. You have a child that's about 10 years old. You would make \$500 a month for your child credit and the cost of living for your county of \$2,600 a month. At 40 years old you will be making \$133,408 for the year that's \$33,800 for cost of living, \$6,500 for child credit and your first pension for life will be \$15,168 per year and for wages you will be making \$51.96 per hour or make \$77,940 for the year working 1500 hours as a tier one in pay.

Well say the same for the next example as I had just explained but you will be working for a tier 3 medical facility or hospital all your life to see what the difference would be. Well at age 40 you would be making if you had worked for 18 to 19 years for a tier 3 establishment is \$64,950 or \$43.30 per hour. Your first pension being of a tier 3 all your life will equal \$12,640 a year or \$243.08 a week for life. Child credit will be \$6,500 a year along with having the cost of living of \$33,800 a year. Your total income would be \$117,890 a difference of \$15,518 a year for the same time worked. Just because your facility or establishment didn't get as high of standards because of receiving more complaints or doing wrong on different procurers that are implemented by the people and enforced by Ace Services justifiers.

Everyone will have the same starting wage of whatever job listing that Ace Services offers. I'll say being in the medical field of a tier 2 bracket will give you 10% more income and being in a tier 1 bracket will give you an extra 20% more of your wages as long as you're a tier 1 or tier 2 you will make more money for having high standards with less complaints.

I will show now what the difference would be from tier one verses a tier three in comparison at retirement of the age of 62. We will say both have the same cost of living of \$33,800 a year and there is no child credit, just your two pensions for retirement and cost of living. So, for a tier 1 is \$81,228 and for a tier 3 is \$73,324 a difference of \$7,904 a year less for retirement. The system will keep it fair for all as complaints that come in and they will be added to whichever establishment, and it could affect whether they're a tier 1 or tier 2. The tier brackets are divided up evenly of the complaints that come in separating equally of 33% per tier that can change daily due to complaints that come into the justifier's office.

Now as far as what General Family Practice Physician or Family Doctor will be making at 26 years of age after college for their first year of income. Realize, a doctor can only log into the Ace Services system for wages only if they have clientele to serve or act on for help so for the future all doctors will set up their appointment in either a 15 minute session, 30 minutes session or one hour session or appointment slot to deal with patients and if they have less than two hours a day in appointments that doctor or facility will only be able to stay available to the public's eye for seven years if that doctors office can't maintain 33% clientele on average.

What I suggest is that there be two six hour shifts open for each doctor's office to see clientele, that could be of one or more doctors in the morning to handle the patients' needs and have a second shift to cover the appointments in the afternoon. Now the doctors will no longer have to work 12-hour days. If the clientele is where it's causing the doctor to work and extra three hours a day in overtime, I suggest that the clinic adds another doctor to the facility to handle the clientele. There should be no doctor working past 10 hours in any given day. If so, Ace Services will contact that office in telling them they

need to get another doctor to fulfill the commitment properly for the people to be addressed by a doctor that's not rested accordingly because putting in long days of being strung out by too much on the doctor's plate where there could be mistakes made.

A starting doctor without kids, living in a population of 150,000 to 200,000 people and we will say that the cost of living would be \$2,600 dollars a month or \$33,800 a year and their establishment is a tier three facility. The amount would be \$183,800 total yearly income, \$33,800 for cost of living and \$150,000 a year starting as a doctor only working 1,500 hours for the year and making \$100 dollars an hour.

Now we will see what a first-year doctor with no kids at a tier 1 facility and receiving \$33,800 a year for cost of living will make. The doctor at tier one will be making for 1,500 hours of work with cost of living figured in \$213,800 for the year. The wages equal \$180,000 alone which makes it an extra \$30,000 more than a tier three and a tier two facility will make an extra \$15,000 a year starting as a doctor. And for a tier one doctor, will be making \$120 an hour verses \$100 an hour at tier three starting.

Now we will look at your 13th year of work at the age of 38, being a tier three facility of all the years worked receiving your first pension and without kids with getting paid \$33,800 a year for cost of living. You would be making \$127.71 an hour with an income of work committed for the year of 1500 hours this will equal to \$191,574 and with cost of living will be 33,800 to equal \$225,374 and your first pension starts that will make you \$30,279 a year for life. This leaves you a total income of \$255,653 a year.

Now we will say everything is the same except being a tier one facility where your total for the year would be \$300,023 that's a difference of \$44,370 from being in a tier one facility verses being in a tier three after your 13th year of work. You would make \$6,055 more a year for a tier one pension at the age of 38 than being a tier three. I had thought that this was quite a difference to be able to receive an extra 20% but I think it's very serious for the medical attention received by the medical providers out there in the world be taken seriously and will be paid greatly for their excellence in commitment and service.

Another example would be at the age of 58 after 32 years of work what you will be making after receiving both pensions and cost of living of \$33,800 a year of working in a tier three establishment all your life. You will be making \$192.01 an hour just two years short from making max pay of \$200 an hour or \$288,014 a year for 1,500 hours of work with cost of living of \$33,800 a year will equal \$321,814 and then when you figure in both pensions of a total amount of \$100,515 a year for life to bring your total income to \$422,330 a year. This should be the bare minimum if work 1,500 hours of work.

Now we will say you were in a tier one facility all your life and your cost of living is \$33,800 a year or the same. You will be making \$500,036 in income a year or more if you choose to work past 57. That's \$230.41 an hour working 1,500 hours a year will make you \$345,617 in income then with cost of living will equal \$379,417 and with both pensions to equal \$120,619 giving you the total of \$500,036. Realize if you were in a tier 1 facility all your life verses being in a tier three facility this will be the difference per year for life you will be losing \$20,104 on your pension.

So, we know we all want to be part of a tier one establishment but actions from the people will decide the fate of these medical establishments. You can see the difference in income as well from a person working and with the pensions at a tier three versus a tier one showing a difference of \$77,706 a year. If you worked seven more years and retired at the age of 65 you would receive \$131,745 for retirement from both pensions combined being in a tier one.

We will use the same cost of living of \$33,800 a year to give you a grand total of \$165,545 a year working for a tier three facility all your life. Or from working for a tier one facility all your life will grant you \$191,894 a year or \$3,040 a week for life. That's to also include in the figure of \$33,800 for cost of living. So, you can kind of see that being a tier one makes an extra \$26,349 a year after working a lifetime in a

tier one facility for retirement. A tier 2 will make an extra \$13,174 a year for retirement at 65 if you were working as a tier two facility all your life.

If you want to figure in what an individual would get if they had kids. Well only one kid can give you credit through the government of \$500 a month or \$6,500 a year. Let's say a couple has three kids or each partner in the relationship can claim one child from the government. And as long as the child is in the care of the one that claims the dependent. They will be able to collect on the child until that child turns 18 years old. If your first child fell off of child credit due to them turning 18 it will automatically place your other child on the mothers list because they should be registered in the system. If they are not already receiving child credit to a parent from the government.

Nothing can be removed from the medical records of the individual from the hub at the doctors' location or any other location. Only the Ace Services Ace of Hearts department can add or change the file only if there are discrepancies that are incorrect in the file. Else wise everything annotated in your medical records will be permanent as time goes along for each person. Numbers 2,501 to 7,500 will be any common medical supply list used to treat the people to where any medical worker will have the access to order anything on the list to have on hand at any facility.

As items on a patient are prescribed or used where they will be annotated in their record, the Ace Services system will automatically order a replacement of whatever they list for said patient to restock the facility or to be ordered to the person's living location. Numbers 7,501 to 10,000 are equally divided into five different categories of the types of surgeries. For instance, numbers 7,501 to 8,000 may cover any procedures or surgeries to do with the arteries and heart and 8,001 to 8,500 may cover anything to do with the activity of the brain in related surgeries 8,501 to 9,000 these numbers may cover joint replacement surgeries.

Dental, vision and hearing will have a different list in the Ace Services system to choose from, of items which would be for the people such as prescription eyewear, contacts, hearing aid or even retainers – anything to do in helping the people. From the last five years going back from the time I would take office adjusting it to America's living and work standards for the world to enjoy is how it will be established as a common average to figure out where the economy will be adjusted to.

No patient will have to pay for the surgeries, medicine or hospital visits nor will they have to pay for office calls at the doctor's office. Your records will be stored in Ace Services database and all people will have the ability to keep an organized record of practices performed where they can view their records at any time through a phone or computer and it will be secured only to the individuals access.

Once the procedures performed by the doctor are entered into their database of the exam and whatever tests that were ordered up of that individual will then go to the Ace of Hearts site of the district. It will be like a domino effect where your itemized list will order up new supplies and pay for everything along the way for each listing as they are to be used. So, if it's allotted will pay everyone that's involved in doing the function of test or tests that are of selection of the itemized numbered list provided on the site for the doctor. It then will be automatically forwarded to the Ace of Diamonds office to pay out the doctor for their services on each individual or anyone within the medical field at the end of the week or two hours after twelve every Sunday morning throughout every year. Because of each itemized number which is used to correlate the payout for the needs within the medical field for everything to flow accordingly.

All medical practices will be paid for by the government. You will no longer need to purchase medical health insurance but there will be outside sources in the medical field that may perform medical services that the government doesn't cover. Examples are such as breast enlargement

surgery, tummy tuck, sex change, Botox or anything that is not considered life threatening like cosmetic surgery. Other examples like nose job, cheek or chin to alter one's appearance will not be covered by the government. You will have to pay for an outside source to perform these types of surgeries and there may be insurances offered to cover these surgeries and procedures performed by outside doctors. The people will not have to pay for regular care."

Walter Davis: "I like what I hear. That seems to be a really good policy for the people. What about medicine or prescription drugs, how would that work?"

Scott: "There will not be outrageous prices for prescription drugs. The government will monitor and will ensure there will be fair prices for all prescription drugs or medicine to be used in treating such patients. You see these pharmaceutical companies that make the medicine are going to be regulated by the government in order to function as a pharmaceutical company not as a company that feel they can charge whatever rate they think they can make money off of like what Pfizer, BioNTech, Johnson & Johnson and Moderna did, like charge an outrageous rate for a vaccine that was less than 33% effective and charge \$1,800 per vaccine. Not only did they make a vaccine that wasn't effective they made 3 more series of the shot and boosters that I consider as not effective that was administered to the people. An article I had looked up said that Pfizer, BioNTech and Moderna are making \$65,000 dollars a minute for the vaccine, that's over \$34 billion a year and it's been going on for more than three years. The people are still getting COVID-19. I'm sure these companies probably made trillions off of the governments around the world.

I believe there are side effects that the public is getting now from receiving the vaccine. Now the people that had received the shots are going through severe systems because of the shot. Also there has been reports of young adolescents in school that are in fit shape doing sports that are simply dying for no known reasons around the world from receiving the vaccine. You realize plagues and diseases happen every so many years to thin out the population to make us a stronger race here on earth. You can't make a miracle cure overnight without having repercussions.

Just like insulin for diabetics they're selling five injection insulin pens for \$1,100 a month for supply and charging these outrageous prices for medicine to the insurance companies and individuals that have diabetes which probably cost less than \$10 to produce. Another medicine is for male erectile dysfunction where it's Viagra that charges over \$25 for a pill that last less than an hour when used. There are other medicines to use like Viagra out there on the market for instance Hims that charge a couple dollars for the pill which is cheaper. This makes me wonder how all pharmaceutical companies are not regulated. In the new world all the pharmaceutical companies will be regulated.

All medicines will have to show as an improvement or increasement of bettering the condition at hand from the medicine to show an improvement through proven results. You hear all the time on some of the medicine out there on the market stating that whichever medicine may inflict bodily harm to you or even death. Now why should anyone take a medicine that can cause harm, which is not a safe medicine to take. I know of two medicines that I was put on that will be removed for the use that it was intended for. One of them is Lithium where it will mess up your nervous system and it messed up my thyroid in my body after taking it. And another medicine to try and control manic break outs is Olanzapine where it did not control the manic episodes that I had but caused me great difficulty in dizziness and I had gained over 40 pounds in less than 30 days being on the drug.

Drugs like these are going to be withdrawn from the market of sales and banned for the peoples use. There will be a couple of ways to prove the worthiness of the medicine. One there will have to be a panel of 100 random people to test out the drug or any drug, vitamin or vaccine and will monitor all body functions of the 100 while taking the medicine. Lab work has to be drawn every

3rd day to monitor the chemical reaction it has to the body and it shall be administered for 90 days to show the outcome from the 100 patients. They are to be observed by the pharmaceutical company that is offering their new breakthrough. Even after the 90 days if there are to be any side effects that are to be considered to be serious it will then be taken or done away with for the consumption of the people for safety concerns of the people.

All medicines, vaccines and vitamins will have to be given the right to sell and market within the government. As each medicine will be well observed through the testing to make sure they're safe for the people then it will have the availability to be on the market to be used by the people through the government. I'm estimating that there will probably be 50% of the drugs that are on the market be denied their rights to allow them access to be allowed to use for the people and will be removed for the protection of the people. Any way a pharmaceutical company will have to show proven results of each different medicine that they say can improve one's health in order to get paid for said medicine.

It has to show at least 10% improvement to one's conditions or health that is administered through the random one hundred participants of the said vitamin, drug or vaccine that would be allowed on the market. There will be standard questions that the 100 participants will have to take after the 90 days they had been administered of the medicine. Ace Services biological medical assessor will verify each medication to be adequately performed through testing. Also, they will verify the results, testing along with the cost to make the said medicine for prices can be adjusted and excepted as for fair for each medicine.

On the standardized test where the answers at hand of all that are to be tested for the effects felt of your body or differences in your health that is noted to respond to according in good results from all tests performed. As far as written questions, there will be an area that will give the assessor of Ace Services the capability of evaluating each question on a scale of 1 to 5 to say how effective the response to the medicine is. If the questions average out with a 4 star it will count for the percentage of goodness across the 100 participants when divided out to grant 10% or more for the positive turn out of the medicine. Between the lab tests that are done and the close evaluation of each of the one hundred shall happen to have any serious problems with the drug or even death it will not be allowed for the people. When the test come in and they can prove results in the patient to be above 10% increased conditions or of being of a complete fix or remedy to whatever sickness or disease or system of problem.

They will be able to charge 100% of what it cost to make of the medicine, vitamins, or vaccines. If the medicine is a complete fix to a person's condition or in a daily need to regulate a person's condition the pharmaceutical company will be able to charge up to 200% of cost to make whatever medicine. Only medicines that are more than 10% effective or better will be authorized for consumption to the public. But there will be an effectiveness on percentages addressed from the testing on each medicine showing how effective it is. So, if it was a chickenpox shot or vaccine it will say 100% effective for the vaccine. If it is a flu shot it may say 30% effective. The results to the testing will show the percentage to be paid for each medicine for instance for this example, Viagra knowing it is a working drug for the middle age male crowd of the world. Viagra will get 100% for a successful drug and let's say 90% for correcting the problem from a study of 100 people to be awarded. If it was not 100% effective in all the test patients it won't be able to show 100% for the medicine or get up to another 100% paid on such medicine.

This will be the standard for all basic medicines and vaccines out there on the market but when you look at rarity of diseases and cases of illness that is not common. If the disease or sickness it is less than 5% of the population the pharmaceutical company will be able to charge up to 500% on top of making of the vaccine or medicine to the government for a total of 600%. If it is less than

1% of the population for the disease or sickness, the medicine or antidote for the sickness or disease from the pharmaceutical company can charge up to 1100% to the government for providing the serum for whatever medicine for said sickness.

For instance, vitamins will be tested for effectiveness so they will be able to sell for a 100% over cost to make but the vitamin isn't curing anything just to keep healthy so the effectiveness of this vitamin will be based off the increased levels within the bloodwork to show the percentage of the effectiveness. I looked up and see there are over 20,000 pharmaceutical companies in the world currently. After the new world order goes into effect there will only be 10,000 facilities that the government will pay to. The ten thousand facilities in the world will get the same replacement cost of their properties as the medical facilities receive and that's .0666666666% to the tenth decimal place.

This number is used in calculating what will be paid to each facility of their assessed property value that's addressed to each facility. This will happen for all of the pharmaceutical companies that the government sponsors separately to get paid out monthly or yearly. The rate of assessed value is meant to replace the cost of the facility every 15 years. These businesses will have to pay for whatever is needed for the lab (like technical equipment). Each year different biological labs that are not sponsored by the government may take an existing pharmaceutical company from the bottom of the list if they are showing breakthroughs in different medicines or solutions for the people of the government.

Also, of animal advancements in medicine and breakthroughs and will have some facilities to cover chemical engineering for the environment to come up with biofuels and agents to be invented though these labs that the government will sponsor. The list of companies will be listed from the most breakthroughs of authorized medicines, vaccines and vitamins and of new advancements in chemicals through proven results will be authorized for the people in the new system. This way only legit medicines and advancements will count for each pharmaceutical agency or chemical agency.

All medicines of credibility will be paid out accordingly through Ace Services. A biologist or chemical biologist will be paid \$30 dollars an hour to start or \$45,000 a year for 1500 hours of work and there will be 20,000 employed by the government only to support these facilities or bio labs around the world. All other staffing of these facilities and any maintenance, remodeling or up-dates to a facility will be provided by the sponsored chemical company.

The new testing will consist of 100 people test results to whatever is to be consider as worthy as a medicine ministered for the people. The ages for testing most drugs and different chemicals to be used for the people will be from 25 to 65 years of age and for children and infants will also be other categories. If the biochemical company developed a new product on the market they will hold the rights in the patent office within the United States of owning the rights of new product or invention for 20 years before any outside parties can open up to the market. This will include whatever medicine, newly developed product or of function.

In the Ace Services system for the doctors to look up the selection of medicines to be able to select from a given set list to use whatever drug in the world through the system for the patient. So as the doctor writes in the condition into the computer, it will show a list of medicines in the computer of Ace Services to be used by all doctors. This will list all the medicines for that condition. It is recommended to use the first medicine from the list due to the fact it has the best review results in testing so if there's 10 medicines from a list, we will use for an example to get rid of a headache, all ten will work but, the one on the top of the list will be selected most likely. It can also be of preference to what the patient would like. If there isn't much difference in the quality of medicine

the cheaper medicine will be placed higher on the list that is suggested for the remedy. Understand you will not see the charged amount for each medicine, vaccine or vitamin only the Ace Services office will show data of this sort to use to pay the appropriate agencies. Everything will be paid for just as the medical is annotated in the records of said patient.

Understand that any pharmaceutical company can reproduce any product that has expired its 20 years granted probationary period for creating something new and all will have the ability to be able to make up to 200% on the cost of making any basic medicine on the market but, understand the cheaper medicine in the system of the same percentage of effectiveness will be used most likely unless they have a worthy name for that medicine that the doctor or patient knows as considered to be worthy.

Over-the-counter drugs such as cough medicine, flu, aspirin, things of this nature will still be accessible through the stores for the people to buy and the government may or may not pay for these items for use. You see, everyone will have the ability to go to any doctor's facility or medical facility that handles appointments where they can authorize a \$200 credit to you every six months to purchase over the counter medical supplies and medicine. Which comes from the government to go into your account only for the use to purchase medical supplies or over the counter medicine of your liking that will be given to all the people from their files. You will only get \$200 of credit at a time every six months. You must be of 18 years of age to receive this benefit and all over the counter medical supplies and medicines will automatically be known while trying to purchase whatever medical supplies in the stores of the world or of the market if it's authorized by the government for purchase of said credit given."

Walter Davis: "That's all good, I like to hear that. What about the elderly who have got to go to care facilities? What would be the plan on this?"

Scott: "Well, care facilities will be monitored and paid for just as the medical facilities and hospitals is figured out. The nursing facilities will get paid (.0666666666%) to their accessed property that will be paid out weekly, monthly or yearly. If a patient is to be in a care facility, they will no longer receive cost-of-living allowance. But the government would allow them a small supplement of money to ensure they can have items such as clothes. There may be extra money allotted for entertainment granted to the care facilities for special functions and activities.

There will be a secondary Ace Services office for caregivers in each community or acting caregivers that are in each community will have to adopted to Ace Services policies and procedures. They would have to abide by and perform the needs for the community. This will also come from the Ace of Hearts office for the assistance of patients that need such care. It will be paid out by the Ace of Diamonds office of each district of said facility and all people involved in the duties of a care faculty will be authorized and decided by the government standards.

So, for an example there should be one worker or caregiver per every 4 patients in a facility to assure the people are properly being taken care of. Also, there should be a coordinator to assure everything is being performed accordingly at each facility. As well as a cleaning and laundry service personnel will be offered at each facility location paid out by the government. If a person chooses to live in their home, they may do so, but their cost-of-living allowance will be garnished due to what the necessity of the care that is to be taken to care for them. It'll be broken down to the set amount per hour that a caregiver spends at the disabled or elderly person or person's residents.

Also, it will only cost the one being cared for 50% of the set hourly wage, so the elderly may continue to live in their home and be taken care of by caregivers and receive their cost-of-living allowance from Ace Services unless the amount of care depletes what you're able to afford. The caregivers would be

able to assist in cleaning or taking care of the house, make meals, and do laundry. Verified medicine is taken accordingly and figured out, help the patient pay for the bills with the patient's money. If the elderly or disabled person needs modifications to their home in order to care for them, the Ace of Hearts office would send a representative out to their location to assess what is needed and then apply the applications that are needed and then be paid for by the government. Different applications for the disabled of accessories may be granted on special request."

Walter Davis: "Your new world policy is looking better and better there, Scott. Let me ask you about dental. What would you do for this?"

Scott: "All dental that is required or recommended by the dentist will be accepted and allowed, braces, dentures and implants included. It will use the same concept for request to the Ace Services branches and payment to the allotted dentist for the work performed. The same concept also applies in figuring out what the cost is to perform each procedure across the world, for then it will be paid as an average to the dentist for the service rendered."

Walter Davis: "That's good. Some dentists may not like the prices they get paid for the work though."

Scott: "I suppose they will have to seek another profession then. It will be fair prices paid to the dentist for their services."

Walter Davis: "What about vision and hearing? What are we to expect?"

Scott: "Vision will be offered to all people to include if you want to get laser eye surgery or any standard frames offered through the eye clinic of any desired lenses. Contacts if a person chooses to have will be paid for as needed. As far as hearing, you will have specialists or doctors in the field of hearing able to address to your hearing needs and if you need hearing aids you will be able to get one set every year or on the discretion of the doctor. Just like with stuttering if there is an aid to help with that medical condition the government will offer it."

Walter Davis: "What about handicap? Some handicapped people need special limbs and special accessories to get around. What would you do about this?"

Scott: "Each person of special needs or artificial limbs and certain accessories would be approved according to what the Ace Services office feel is needed."

Walter Davis: "What was this I heard about free fuel?"

Scott: "Yes, let me tell you a little about it. Anyone around the world will be able to pull up to any public gas station and fill up their car with free fuel. You see the basic gas with like 87% octane will be free and if its 89% octane it will be .30 cents per gallon, 91% octane will be 60 cents a gallon and 93% octane will sell under a dollar per gallon. Electric cars will also be free to charge its car battery from any outlet that offers the plugins to the public. You see, all public gas stations or establishments that offer gas and or electric charging stations around the world will get paid 5% of their automotive property assessed value per year.

So, if the gas station was valued at \$400,000 the owner would receive \$20,000 a year, plus 10 cents per gallon of all the gas that is offered. Plus, the charging stations will make 10% profit from the electric cars. If you had went through 4,000 gallons a day in 28 days this would equal \$11,800 of profit at 10 cents per gallon.

Now when you pull into a gas station in the future it may be like a super store offering everything

to do with automotive. Whether it's a car wash, a service station, an auto store, or these future gas stations can offer window tinting, or custom wheels. It may also offer a detailing service to clean your car or whatever the establishment wants to have or create, to where it will pay for the establishment in 20 years by the government because of providing a service to the people.

You see, there will be a program to connect to each gas and electric facility that will show the number of gallons pumped or electric used. This will automatically relay the amount used to the Ace Services office each month of what will get paid out. The different prices of the gas will be paid from that gas station to their supplier. The gas prices will have to be paid out from the government with fair prices of all oil suppliers around the world. It will be adjusted to what it costs to make ethanol or other biofuels as is common. Where I would like to only use 10 to 15% of natural resources at any given time and have other substitutions in order to make the natural oil last longer. The oil fields of governments around the world will be used as needed for the people. If the competitors wish not to sell at a cheaper price they will just sit on their oil."

Walter Davis: "Interesting, basically free gas and there may be super gas stations. I had also heard something about in each community in the world is going to have recreation centers for the people.

Scott: "That is correct! Every community that has a city council will be able to have the community come together to decide what they would like for entertainment as an establishment for the people. It will be up to one million dollars to design and build a recreation center for the people of a 500 populated community. For a community of 1,500 it will be up to two million to spend on a facility. For a population of 3,500 will receive up to three million to create a rec center. For a community size of 10,000 population will be entitled to receive four million to build whatever the community wants for a rec center. 50,000 populated community will get five million to build a rec center. 150,000 populated community will get 6 million to build a rec center. 250,000 populated city will get 7 million to purchase the land, designing it and completion of the establishment. 500,000 populated community will get eight million. If a city has seven million people that city will be authorized to have seven different rec centers amongst the city and each one will have up to 10 million dollars to purchase the land and construct the rec center. Special request from different populated areas may be authorized to build an extra center.

These centers can consist of having a pizza place, sub shop or a grill for food inside of the rec center. Far as designing the entertainment or what you could possibly put in your rec center is an arcade, climbing wall, racquetball courts, basketball courts, swimming area, hot tubs, jacuzzi, sauna, weight rooms, tennis courts, pickle ball courts, bingo hall, bowling alley or maybe a pool hall with a bar in the rec center. Whatever the community decides for the rec center to look like and of its function it will make for the community that will make it different from the next community.

One person will be in charge or put on the payroll to organize everything that has to do with the rec center. This will include putting in a request for positions to the city board to open it up to the public in order to fill the positions to be able to upkeep and run these rec centers. So, if there was a local pizzeria in a community the city board can leave it up to the public to have that pizzeria operate in the rec center if that pizzeria wants. The expense to make the pizzeria restraint could come out of the cost for building the center. Each establishment inside of a rec center will have to be able to offer fairly cheap pricing on food and drinks. The food establishment inside of the rec center will be able to keep all their earnings.

Walter Davis: "Well, Scott, it's been a real pleasure speaking with you today. The people will have a luxurious life. But unfortunately, we're out of time on this episode. I can't believe it has been three hours already! I thank you for coming. I'm Walter Davis of *20/20 Exclusive* until next time. Have a good day and think about what the new world order from Scott Chally could be like if it's implemented."

Patricia Klein: "Hello, my name is Patricia Klein and I'll be interviewing Scott Chally tonight on *Nightline on Target*. Many people believe that Scott Chally is the Messiah that is spoken about from the Bible to bring forth to the world a new world policy. Scott, I'm glad that you can make it here tonight to have this interview with me."

Scott: "Sure, no problem. It's an honor to be here."

Patricia Klein: "First off, I would like you to do a quick summary of what you expect the world order to do while in operation if and/or when it's applied."

Scott: "I see the world to have peace and salvation in the near future, where the people will all be taken care of financially, medically, through education, and be treated fairly in the workplace and have rights as citizens to speak up for something that they don't agree with by suggestion boxes placed in every post office. The collection boxes are to stand by the right of the citizens when complaints are filed. All complaints will be carried out whether for the good or for the bad of the people from the justifiers of the Ace of Spades leadership office in each county."

Patricia Klein: "How would you know which situation is considered fair? Whether it's good or bad for one's party or opposing party when it's handled by the leadership office of Ace Services?"

Scott: "Well, all disputes that come in will have to be handled through 5-person justifiers investigating and judge team from the leadership office of Ace Services. But more serious cases will have to be presented in front of a judge in court with a 15-jury selection panel setting to decipher the outcome of the crime or situation. Which it could grant discipline, punishment to one's party. Whether it is to take a point away from a manager in a leadership position, or a dog keeping the neighbors awake at night. This is to uphold a wrongful complaint against the opposing party, which could be justified as a fine. The party that had the actions against them may appeal to a court, but more serious penalties could be served if found at fault. If the party is found guilty in court, they could serve time in jail and a fine or both. When the justifiers investigation team looks into a situation, they will be thorough. All actions carried out will have a second check to verify suitable or fair punishment was addressed. There will be a second justifiers team to come up with a solution for each case and the lesser of the two 5-person justifier teams will be given as a choice to the one at fault to choose the lesser of the two evils and will be final."

Patricia Klein: "Explain to me a little bit about the college education benefits that you would have available for the citizens."

Scott: "Well, it mostly will be entitled to graduating high school students for future generations to excel into the workforce place. All graduating high school students that attain a scale of or equivalent to a 2.0 grade point average or better out of 4.0 grade point scale or three out of the six-point scale depending on where you're at in the world if he or she attains half of the grade scale requirement, they are entitled to get \$25,000 per year to go to college or go to a secondary school. Adults that have been out of school for more than five years or don't have the grade scale from school or also students that had a grade that was under the guideline, may seek tutoring in order to raise their equivalency and by taking a test to qualify for the money to go to college that will be free of expense to all. Each person that applies for the education money may seek education up to eight years being paid by the government as long as they pass their college classes to maintain a suitable grade to stay in school, college."

Patricia Klein: "Will there be any changes in the school system across the world? Or what could you tell me about this?"

Scott: "First off, all the schools around the world will have to incorporate the English language into the teachings of all students as a primary language. I figured it will take about five to ten years before we can switch all schooling as the same standard across the world for all grades to achieve. I'm making all the teachers of the world as if they were reviews of book's ranking from 1 to 5 star. There will be set categories for each of the teachers by what grade and what area's being taught to the students. For instance, all Kindergarten teachers will be of one category and let's say a high school teacher of biology will be another category, with special education teaching being another category. Whatever category they fall into will be what they will get paid for of a standard salary teaching job in the Ace Services system and will be the same across the entire world.

There's an incentive that I will explain. You see, the last week of school each year in May is where all the children of the world will have to take test over what was taught to them over the course of the year. All test will be a set standard for all the children to the appropriate grade level. Where the average should be maintained at a 70% achievement in passing each grade as a set standard to try to achieve. With all the kids being tested this will show how the teacher had performed in teaching the information provided to the children or on how the children have achieved from their teaching. If a teacher does well in their teaching, they will get compensated for it by making more money.

Let's say the average teacher makes 45 thousand a year teaching. Well, it will be the starting wage if your kids test out below 60% on average. If the classes you thought tested out above 60% to 70% you would get a 10% pay hike to your check. If the students' average was between 70% and 80% you would get 20% pay hike for the year till the next testing period comes around. From 80% to 90% of the children averaging out on the year ending test will be a 30% pay hike. From 90% to 100% it will be a 40% hike in pay. From 100% to 110% of the children testing out at this percentage will allow the teacher to receive 50% pay hike to their wages for a year.

There will be many extra questions on the test, each year of testing to see how advanced the individual is which will calculate out to 110% if all questions are achieved correct. The placement on how the children do on their testing will compensate the teacher for how well they had taught. Realize after 34 years of the pay that you were making; it will have doubled because of the yearly revolving rate of (.0205959100) to be added for each year of commitment or service. So, if a teacher was on their 35th year, they would be making double from when they had started and plus if they were an exceptional teacher, they may qualify for a 5-star teacher making an extra 50% or half their wages to be increased as well. That's not counting for the two pensions and the cost-of-living allowance they would be receiving.

Now as far as setting up the standards for the world education system. This will be of my hometown Monticello, Iowa where me and most of my kids had gone to school. They will establish fair education standards for all the grades to include kindergarten and special education. They will organize what needs to be taught at what grade in school along with all testing and educational materials that will be needed, which will be the new standard across the world.

Private schooling will not be paid for as an opportunity to choose from by the government. This will cost extra where the private schooling will charge the kids parents a set rate of that special schooling they choose. All private schools must teach the same material set as the standard. Extra teaching or learning may be possible form private schools. The teachers for private schools will be paid through the government as other public schools are paid and will be evaluated as all teachers of the world are. Longer hours of schooling may be available with a lunch each day of schooling for the people to choose this route for their children. No money will go to the facilities to update or to purchase major supplies other than the basic supplies a school would need. The supplies needed for the schools will be at easy access to all the teachers who need to order up supplies will have itemized numbers showing in the Ace Services system to order from.

There will be 190 school days or 950 hours in a school year and each day for the children will not be longer than 5 hours 20 minutes. For instance, if school starts at 6 am in the new time set for the world where that class or all classes will be broken down to one-hour with 5 minutes between each class. The kids would be done with the 5-hours of school at 11:20 am and the teachers would have to show up before the kids, and leave after the kids have gone home. There will not be lunches at school anymore and any extracurricular activities will be up to each school to schedule.

For all coaching for any academic sport or activity, there will be a set rate of 30 dollars an hour for a minimum of two hours per training or activity. This includes also for refereeing games, judging contest and chaperons for dances, etc. All teachers will be in the system to receive this pay so they can log in any time for any activity they participate in. All activities will show for what different teachers are to support and participate in coaching and, or of the different activities, showing in the school's site. This will be layered on top of the Ace Services site to intermix to show what's being addressed within the schools.

Any sports equipment or other money needed for other activities or items of need would have to be authorized by Ace Services office. When special funds are needed for updating a school facility or equipment needed there will be two people per county or district or two per every 100 thousand people in a county. They will be handling the special request for government funding to the government owned establishments across the world in each county or district. This person will decide if the establishment will get the money for whatever is to be needed decided by government guidelines. These people will authorize it to be given or granted. The transportation of the children to and from school will be paid for through the government like it is now to be able to transport the kids.

The schools can keep a slush fund from the proceeds from games and activities they offer to the public to use as they wish for the children of that school. You see, I want to recognize the excellent teachers of the world. So, in July of each year there will be an awards ceremony for all the outstanding teachers of the world.

The performance test taken at the end of the year from the kids will show where that teacher sits within the ranking system of all schools across the world. The top 25 teachers from each category will be recognized around the world. There will be from kindergarten through 12th grade of all the areas of teaching, realizing that there are multiple courses offered throughout school which will be decided by the Monticello School District of the required courses to be taught to the children. Teachers to qualify for the 5-star payment system by the government must teach in three classes per day as a regular full-time teacher. All other teachers will be paid as part time of the basic rate of pay and rate of yearly percentage for said teacher for their commitment in teaching. Part time teachers will not participate in the list of teachers within the world and will not be evaluated.

There should be roughly 52 teacher categories to cover all the education taught. This will consist of 1,300 of the best teachers in the world to get recognized for their outstanding teaching ability. All the teachers that make the top 25 of each category will get \$10,000 within one week of all testing has been completed and sorted to show a list of the best. There will be assigned advisers from the Ace Services offices overlooking the schooling system to ensure all is handled accurately and fairly when the end of the year testing is administered and sorted out for the results.

The winner of each of the 52 categories will receive \$100,000 for outstanding teaching. All 25 teachers in each of the 52 categories will get an award achievement certificate and trophy for their accomplishments. No child should get turned away from any school due to their education level, nor be subject from testing when evaluated, all will be opened to the free rights as equals.

Patricia Klein: "How would the cost of living to be paid out?"

Scott: “The average cost that it would take to live per district or county would be entitled to each person to live off of. For a small community of 3,500 people, it may be \$21,658 a year or \$1,666 a month for the entitlement to each living person on earth. If it’s a population is of 150,000 to 200,000 it may be \$2,600 a month or \$33,800 dollars a year that everyone will get paid in that county of whatever city it may fall within the limits. You would have to consider the cost of utilities, housing, new autos, insurances, and food. What’s listed will be regulated so they won’t fluctuate more than 10 percent a year. So, two individuals would make \$43,316 a year plus whatever they make working and living in a small community of 3,500 population.

There will be one other service provided to all the people of the world and that is to give \$200 dollars for travel expenses each month or up to 2,600 for the year to include plane travel, bus, train, taxi, ridesharing or anything to do with traveling will be accepted for this credit granted. This will automatically be added to an account of a generic government credit card file on each individual, for each revolving month and can only be used on traveling.”

Patricia Klein: “So what about taxes?”

Scott: “There will be no actual federal, state, or local taxes. But there will be property assessment dues of 1.3% across the world to be paid every year for the land does not get locked by individual companies or people for the justice of their profit. All wages made are nontaxed. And there will not be a local tax put on commodities. If you receive an inheritance of \$10,001 and more, that amount of money will have a 33 percent tax applied to it. Payable at the end of the following revolving year. If it is not paid for by the end of the following year, a 5 percent tax increase will be due on said inheritance to equal to 38 percent for the second year and so on until the sixth year. If the sixth year comes and the money of the inheritance was not paid which would be a total of 58 percent of the inheritance at said time, that individual’s property will be liquidated and a mandatory one year in prison would have to be served. Remember, \$10,000 and less is nontaxable. Certain charities will be excused from taxes of inheritance money. All alcohol, tobacco, nicotine, THC, CBD, marijuana and cocaine products will have a 33% tax figured in at the sale price of the item to be sold.”

Patricia Klein: “How would law and order be handled in this new world?”

Scott: “Every community of 500 or more people will be able to operate as a town or city council to be able to govern the peoples wants and desires throughout each community supported through the Ace Services offices across the world. These councils will assure that all storm drains, waterways, street repair or water or sewage is adequately provided to the people along with anything that the community desires can be addressed. The town or city board will vote for different projects to occur but can’t have more than five ongoing projects that consist of one million per or more in cost at one time.

A council will consist of six board members and a mayor to hold all the seats to a council. It only takes two members from the board to motion for approval of the agenda for it to be acted on. These members will get paid salary and are to look into what the community is needing and wanting to achieve for the greatness and needs of the people. Town or city meetings will happen twice a month or every two weeks in the evening and will be televised to whom all who would like to view the public meeting from the Ace Services local site.

You see, the public can already see televised videos from town hall meetings and now it will automatically be linked to the town or city site you’re affiliated with. The hours will be listed on the town or city sites for each council meeting. It will show what’s on the agenda for each meeting along with other events and a community highlights page. The agenda for the council meeting on the site will have to be set up for the public to see not less than 24 hours before the meeting.

The age to hold the position of a board member is from 28 to 78 years of age and it will be for seven years at a time for each election. The wages for the board members to hold a seat on the council will vary depending on the population size of the community, town or city. For instance, a 500-population town the board members may get paid \$15,000 a year and a community of 3,500 may get paid \$35,000 a year and a city of 150,000 may make \$65,000 a year and a city board member of a million population or more may be making \$125,000 a year. This will all be sorted out before the New World Order comes into effect.

There will be an annual revolving increased rate that will be added to all government workers that are on the payroll for every year of service to be figured of (.0205959100). If a member resigns from the board position or death; a new member can be voted in for the period that is remaining till the next election. Elections will be digital through your phone or personal computer where it will show of each election for voting and laws to vote on as they come forth in society. A lot of cities have a website to go to but this will list all the sites for that community and there will be a community page when you look on the menu within the Ace Services site of each community. There will be a listing of attractions, parks, restraints and of activities that community would like to share with the public.

This site will have to be set up by and regulated by the city to offer to the public. Just like on how the towns, cities, counties and state workers function now throughout the government with job positions. It will be in the system of Ace Services of all the different city, county and state workers of jobs for pay. All other jobs for each community of the government beside the fluctuation of board members will be paid out as a set standard of pay for each job position across the world, no matter how big the community you live in.

All city workers will be on salary where they will make a set amount for up to an 8-hour day of work. The jurisdiction of a town or city will only be of their limits of the city to handle. County will take care of all the rural areas and small communities that are less than 500 population that are within that county. The board members for a county and the way they proceed with their hearings will be the same as it is for the town or city but instead you call them board of supervisors for the county with a chief supervisor in charge.

Patricia Klein: "You have talked about how the towns, cities and county's function but what about laws for the people?"

Scott: "Everything I state in this New World Order will stand as law. As new laws come into play old laws will be removed from the books starting with town or city, county, state, federal or country and world. The Ace Services office will address the request received in each suggestion box from any post office. The people will put in a request to change a law or to consider for new law, amendment by the people throughout the world of each community. The Ace Services justifiers' duty will be to take the action and communicate with the individual that submitted the new law of change. This way they will make sure what they had addressed is correct. They will gather all the details to be added which would be needed to address a completed amendment or law change. Or a law can be stricken from the books.

One law I will take off the books which holds a 5-year prison sentence is "gathering". This is a ridiculous charge that the authorities use against a person when they don't have no real charges on that individual. Laws like this should be done away with by the people speaking up.

After the justifier sets the proper format to show the new law or amendment. It will be opened up for the viewing public to see on the Ace Services site under Suggested Proposed Laws. This will take up to 6 days before it shows on the Ace Services site.

Any person can suggest anything for law that will fall within the local, county, state, federal or country and world. The authorization of each category of what laws will be authorized per sector. This will be decided by a poll of a law assessment team on what would be considered fair for the people addressing all the different levels of the economy to be able to configure a basic outline for each addressed law group.

Once the suggested proposed law is in the system, all the people within any jurisdiction of the government will be able to see in their files of Ace Services of Suggested Proposed Laws tab. If you open that tab up it will show you a listing of city, county, state, country and world. When you select into one of them locations it will show all the proposed laws in a long listing on a page that you can look at by scrolling up or down on. Where you would have to decide if you want to vote for any suggested proposed order listed. These Suggested Proposed Laws will only stay active for one year on the government site. Then it will fall off of the list and stay on record to another list showing each year that has passed. This will work the same for town, city, county, state, country and world. Even if it is close to the next level of voting.

Only if you chose to accept to the suggested order where you can select and accept the icon on the screen. Of all the people that had clicked on the acceptance icon for whatever law is suggested will show for a count of people who have all agreed with the suggested proposed law. It will also show the number of people living in that jurisdiction as a total. When you have 1% of the people to select yes for whatever suggested proposed law from whatever jurisdiction it is from.

It will be capped at 1 million people for state and country and for a world order, it will be capped at 5 million yes votes. It will then be added to a suggested voting form within the site to vote only yes. This will be listed to all the people of whichever election jurisdiction within the world for the second step of achieving 10% of the votes in 30 days. The new law or order may be accepted after a few days of being listed if it reaches 10% of the vote and will move on to the next step of the voting. This page on the site will have a clock running down to show the amount of time in days, hours, minutes and seconds in order to place your vote. When the clock runs down to zero then all voting would be official to where there will not be any more votes added or canceled.

The first voting takes place after the Suggested Proposal for Law was added to the systems of open voting. For the order to proceed forward, it will have to maintain 1% the voting population of a yes vote. The second poll will have a timer and only to allow 10% of the people to select yes to accept to the suggested law. It will show a count for votes verses the actual amount of people that can vote in the system of whatever said jurisdiction on each of the voting platforms.

The third step will be after 10% of the vote from the population from said jurisdiction to start the final round for said proposed law to come forward for the people to vote on. For world let's say there is seven billion people on the planet. If 10% of the people capable of voting are 18 years of age of whichever voting jurisdiction is being voted on of any proposed order within the system will stand. Then will go on to the next step and be voted on as a legal order or amendment of law.

This will allow all the people of the world to have their right to participate in our justice system. For the world there would be about 500 million votes to trigger this election from the people to have the world council to act on the new bill or proposed law. Once 10% of total votes has been achieved the Ace Services Ace of Spades Department will have to enact the law or bill a second time for official ruling to be decided by a yes or no vote of a 30-day timed period.

This will be for the official final action of what the people will decide for the next 30 days in a timed monitored election of said bill or law. Everyone within the election's or voting jurisdiction will be able to cast their vote for whatever proposed laws or bills that are up for voting by saying yes or no.

For the world council only after the second voting step of 10% votes that are achieved. The United Nations Committee will correlate a meeting and discuss the importance it would be for the people. For 30 days after the meeting, they will continue to research the necessity and importance of the proposed order for the people. 30 days from the first world council meeting will be a second hearing to look at and hear the results from different cabinet members and possibility of outside agencies to have looked into the proposed order by the council.

When they meet the second time for the proposed law, it will then be voted on by the 150 world members from each of the acting countries as the world conference to accept or deny the order. If they denied the law or order it will be placed in a file for the people to look at on the Ace Services site but will no longer hold any weight for a law and order, it will be considered thrown out.

If the majority of the 150 world council members decide for the amendment or new order it will go on to the next step or the final step. If the vote on the world council is a tie of 75/75 that is when the 151's member or leader of the world council will place his or her vote to break a tie decision. This 151's leader of the world council will have to make all tie decisions on laws and orders within the world from city, county, state, country and world.

This person is to hold the top seat in the world council or government and will come from the Chally Royal Family Tree. This person will have a special folder for all the orders that end up with a tie for he or she can vote on them to accept or not to accept.

Now this order had made it this far to where the world council had voted 'yes' for it. Now it has to be placed before the world to have a timed 30-day voting period. This is to allow the people to vote on whatever said bill, amendment, order, or law as a world policy. Just because it may have made it this far. It will have to be the majority of the worlds favor on whatever is decided on. In order for it to be addressed as a new law or new order given the majority of the people has to except to the order and the vote timer has to run out of a set 30-day time period.

I will leave the option to change your vote any time during the countdown of the proposed law till the time has expired. This way if the public finds something disturbing for said suggested proposed law within the 30 days they can change their opinion. All new amendments of laws, laws and orders will be effective immediately after taking the majority of the votes on any election of voting of the people.

Candidates for each country can be listed for election within the system for the people to see and vote on. This will happen one year out from filling the position of election from the people.

Patricia Klein: "Wow, Scott, you had covered quite a bit there. Let me ask you this about the election. Where are you going to be the night of the election?"

Scott: "I plan on being at home watching the election on TV."

Patricia Klein: "You don't plan on being in a public place to speak if you get elected?"

Scott: "I'm sure the media will find me."

Patricia Klein: "But you would give a speech to greet the nation, right?"

Scott: "Sure, I would! I'd be proud too!"

Patricia Klein: "Well, Scott, thanks for the discussion we had here today and answering my questions."

Scott: “No problem, thank you, Patricia!”

Patricia Klein: “Well, that concludes all we have for this episode of *Nightline on Target*. Until next time. This is Patricia Klein, see you later and have a great night.”

News Reporter 3: “You state the 195 countries now, but earlier in one of your broadcasts, didn’t you say something like you wanted to reduce the number of countries down to 150 countries for the world? And have one member of the royal family to decide any tie vote within the world and stand in on the United Nations council when they’re voting on any situations for the world?”

Scott: “Yes, that is correct. Someday soon we will be reducing the 195 countries to 150 countries. And there will be a UN Senate for all countries in Monticello, Iowa to meet up monthly to make decisions for the world that’s been presented forward of new laws or possible problems that may exist. It will be set up as a video console across the world to carry out decisions that are addressed on a weekly and possibly a daily basis from one meeting to another unless there’s an alert set forth for immediate meeting. There’ll be representatives from each country to hold these positions.”

Reporter 1: “Can you tell us how peoples employed working hours will be for the people of the United States and the world?”

Scott: “It’ll be set up as five or six-hour workdays, thirty-hour week for a full-time job. Any time over six hours or up to eight hours will be paid time and a quarter an hour. From eight hours to ten hours in a working day will be paid as time and half. Anything over ten hours will be considered double time. An exception will be contracts by businesses to employ people for tasks or jobs they perform. All salary workers will be based off of a thirty-to-forty-hour work week. Not to exceed forty hours because it’s based off, up to eight-hour days for a five-day week commitment! Salary workers will only have to log in during their shifts schedule within the system that is set up by the employer and can log out as soon as they logged in to show for the work day. Whether it’s one minute for five logins for the week of work where you will be paid for the set standard of 40 hours because you’re on salary. If a salary worker works past the hours of scheduling for that salary worker, when logged back in. They will get paid overtime for whatever time they work past their allotted eight-hours from the schedule of the employer.

And it’s up to the employer to instate to their employees if they want their workers to do overtime, not Ace Services. Any work performed by employees will come out of the employers account with no exceptions to reinstate the money that was paid out from the employer of the employee’s worked time performed. All business out there in the world that employ people will have to pay 30% of their workers’ wages to the government for that workers retirement pension. Where the Ace Services department will automatically figure it for each wage period to be deducted. Businesses that employ 25 people or less will not have to pay more than 15% of the wage to go for the workers pension and the government will cover the other 15% for retirement. There will be no such thing as mandatory overtime anymore. If people are sick, they must get a doctor’s note in order to be excused for employment. That’s if the employer doesn’t allow any personal days off of work each year. No one will be fired for such situations or cases if they get a doctor’s excuse. It will not affect their employment record. There will be no rates for standards that an employee has to perform in any job. I suggest

profit-sharing for the employees from businesses to ensure a steady flow of work for the business. Next question!”

Reporter 2: “How will your Royal family and other Royal families around the world be taken care of far as money in the future?”

Scott: “It will be instated when the people of the world answer ‘yes’ or ‘no’ of what percentage they would like to donate to support the Chally Royal Family Fund or Any Royalty out there in the world. The Chally Royal family fund will be opened up to all the people of the world to choose to donate a small percentage from their cost-of-living allowance given monthly. Where other Royalties will have only the jurisdiction of the people that fall under their rule within the kingdom and it could consist of multiple territories under their jurisdiction of rule.

Realize the most anyone would be able to donate per month would be under a dollar. And that would be due to having to live in a region on earth that has the controlling of Royalty. There would be an option to donate to whatever countries that have Royalty in them with the same set standard for the people to donate equally depending on where they’re at in the world. It will be withdrawn or deducted from your amount to receive for whatever counties or districts cost of living is set at. There will be a list of questions that will have to be answered along with different important information that will be needed from each individual when signed up for the New World Policy.

When you sign up, there will be three options to choose from. The first option will be ‘I would not like to contribute to the Royal Family Fund’ and the second option will be ‘I would like to donate ten thousand’s percent .0001% to the Royal Family Fund from my cost-of-living allowance each month’. That will be (10,000) ten thousandth percent or will equal between .015 to .045 cents deduction from everyone’s pay of the monthly cost-of-living allowance that selects this option.

And a third option will be ‘I choose to donate (1,000) one thousandth’s percent .001% of my cost-of-living allowance to the Royal Family Fund.’ This would be equal to .15 to .45 cents per month per person on average. This will be the same selection for all the people who fall into a Royalty category where I suggest that the people should choose to support the ancestries of Royalty across the world.

How the Chally Royal Family Tree will be set up, there will be three main branches for the money to come in and will be divided accordingly. The first branch will absorb 60% of the total amount made each month of the Chally Royal Family Fund, the second branch will absorb 30% and a third branch will absorb 10% to equal 100% of total money granted or given from the people of the world.

The system will allow it to divide evenly with the members of the Royal Family Tree equally through each tier for all members instated by me - (Scott LeRoy Chally) - of who I will accept in the Royal Family Tree while I’m alive. The first branch will have 400 concubines that I choose to bear my future family. Where all 400 women will be in a palace together where they will receive 60% of the total Chally Royal family fund amongst them until each woman bears a child.

I figured each woman that dedicates their life to me and raises our children that we bear together will get on an average of between \$3.5 million to 35 million a year each. Realize this branch along with all three of the branches will have four different tiers to them. This is for when the future generations are born. If all four tiers have family within them from the 400 women, the first tier will receive 60% of the money donated from the world divided evenly amongst the 400 women. Then the second tier would receive 50% of their mother’s percentage from the 400 divided evenly of the total 60%.

Of the 400 woman, they each will have .25% to inherit part of the 60% allotted total of the Chally Royal Family Fund for this branch. The second tier down would receive the full 30% that is allotted for tier 2, tier 3, tier 4, until they have a child then it would be 18% and the third tier down would receive 40% of the 30% from the parent of tier 2, which then tier 3 will be 12% until he or she has a blood line child then he or she would get 8% and the fourth tier or the last one would receive 33.333% of parents share or 4% amongst everyone or all children in that bracket to be evenly divided out.

Or a better way of putting it, when the concubines have children from me, then they would only get 30% of their gifted money divided from the 60% between the 400 women for that leg of the branch. So, since the newborn child will actually be making 30% of one of the 400 woman since the child have not birthed any children. Until they do, they will get the 30% from their mothers share of the Chally Royal Family Fund and after they have a child this will reduce their share to 18%, and the new child will be getting 12% from their mother or father in the direct blood line. When the fourth generation comes, it will then receive 4% from the blood line parent of 12% leaving that tier to the parent to be at 8%. The percentages per branch must equal out to 100%. 50% for the first tier and another 50% divided up between the other 3 tiers. In the beginning this bracket will receive the full 60% of the Chally Royal Family Fund amongst the 400 women until they bear children from me.

The second main branch of the Chally Royal Family Tree will be of receiving a total of 30% to me and my 7 children and their kids and kids they shall have in generations to come from the people of the world. I will be receiving 15% for being in the first tier for the world's total donation to the Chally Royal Family Fund. And my 7 children will be receiving 15% to start with, divided up evenly amongst the 7 of them or 50% from their father's total of 30% that is used for the Messiah's branch line. My children will be reduced to 8% or 46.666% will come from the parent of the second tier when they have a child or children and their newborn will be getting 7% due to the fact that he or she hasn't had a child yet. The last bracket will receive 42.857% from the third-tier bloodline parent to equal 3% total for all siblings in tier 4 of this leg of the tree. The first tier in all 3 branches will be the standard for all set amounts coming in from the Chally Royal Family Fund. Unless that leg doesn't have any children or family when he or she passes away their leg will be absorbed into all the other legs of that first-tier branch.

Each person in the first tier will be receiving the max total for that leg to be divided out between the 4 tiers of generations that is meant to separate each leg's immediate family members. The percentage allotted for each tier will be divided between the number of children in each tier from the parent granting part of their percentage to the next lower tier.

It will be a set standard for each branch to grant the percentage for the next lower tier in the leg. Back to my immediate family line where the fourth line tier where their child will get 3% of the 7% leaving the parent with 4% that they're allotted for the third tier.

And for the last bracket or limb on the Chally Royal Family Tree will be of a total of 10% of world donation divided up according to all I feel are worthy to receive money from the Chally Royal Family Fund. (At this time, it shall be of my aunts and uncles, first sons' mother, parents and of her aunts and uncles and my wife's aunts, uncles and of my sisters, brother-in-law.) This will equal to about 31 members to hold the first tier of this branch of 10% of the total of the Chally's Royal family fund.)

For the second tier it will be 6% given or 60% of the bloodline parents' allotted money but, if there are no dependents of children, they will get the full 10% of the total Chally Royal Family Fund divided between the 31 members of the first tier. Remember the second tier will now have 3%

while the first tier will have 4% of that leg's share of money.

The children of the third tier from the second-tier parent will get divided up between all the siblings of the third tier of 3% or of 50% from the parents share of the wealth unless there is a bloodline child born to the fourth tier where that new member of the family will get 1% or 33.333% from their bloodline parent from tier three and then the parent of the third tier will get 2%.

When someone dies within the branch, for instance if it's me, my children will move to the first tier of 15%. If they have no kids in the tier under them, they will be receiving 30% between all seven that are in that first tier. All seven will be evenly divided and when my kids have kids and where their children would be evenly divided in the second tier from each parent, leg or ancestor of the Chally Royal Family Tree. Their parent will receive 15% divided up amongst my seven kids in tier one if there are more than two children revolving to the next higher tier, they will only be able to collect the share of that immediate family member who have passed. (Like for instance being the children of my aunts and uncles who have passed away where their kids will all move up to the next higher tier of their bloodline. They will be divided evenly amongst the tier of the allotted percentage granted for that parent or member that moves on to heaven.)

So, it will always hold that divided amount for the number held bloodline slots to be paid out that way no branch will get off weighted taking someone's family line entitlement of money. If a branch shall not have any bloodline children to carry on the generations, that line will be terminated after all surviving dependents have perished. So, out of my seven kids if one chooses not to have bloodline children or adopted children, when they perish from this earth their allotment of money will get divided up amongst the other six siblings for their future children to climb the tree with. Or if a baby is born and dies shortly after the parent had the child set up to receive their earnings of what is entitled, the parent will automatically get back to their percentage or will automatically be divided out once submitted amongst all the children of that parent.

All children to be adopted or bloodline conceived, should be set up to receive their portion of the Royalty money through the Ace Services system of Chally's Royal Family Fund within 84 days or three calendar months. Once I go to heaven, the family bloodline will be permanent where there will be no member added or removed only having bloodline within the tree. If a bloodline parent instates an adopted child to the Royal family tree. That child will be able to live their life out by receiving a portion of the Chally Royal Family Fund. If that non-bloodline dependent has a child, their child will not be entitled to be in the Royal family tree. Only when the next tier down advances a tier.

All members that are considered spouses, love companions connected through marriage, whether there were just two in the relationship or of many partners connected to that bloodline individual, all the people in a relationship in recognition of marriage will have the right to receive the Chally Royal Family Fund from that bloodline member, lover until they have all perished off this earth. The Chally Royal Family Blood Line Roots as well as other Royalties around the world will be cared for by the people of the world for eternity. When the New World Order goes into effect, all Royalty will be able to keep their positive accounts and money in property or of assets of whatever collection of items that they may have. This will include to have up to 100 different properties of not more than 10,000 acres of land allowed to be tax-exempted. The cost of any assessment dues on property of the Royals Inherited Estates for the future and land that is owned to be accessible to the inline main members of the Royal Family as what they chose to divide up. After Sunday, January 24th 2027 is when all nations will relinquish all control of their country to the New World Order of Ace Services or also known as American Constitution of Economics. So, no country or Royalty will have any control anymore after that date to include ME... Okay, next question!"

Reporter 2: “You mention you want to have 400 wives or concubines to live in a palace for the people of the world to donate to and support your family. And why would the world want to support that for?”

Scott: “I’m not asking for much from everyone in the world. I wish and hope for the people to support the future generations from God’s holy son here on earth to open it up to 400 different generations throughout the world that will be bearing my child. This is for the future people of the world may be connected someday to me, the Messiah’s bloodline.”

Reporter 2: “That’s great the way you put it. But let me ask, how will you know what women from within the world to select or how will you be selecting the women?”

Scott: “It will be easy for me since all I have got to do is on Facebook look at all the beautiful women from the different sites showing these beautiful women. I will accept of my liking with a red heart for a like for that picture of each woman that I find beautiful. Where I would like to hear more from the one, I had liked with a red heart on Facebook. If I gave you a blue thumbs up on a picture that means you’re close and try to post another picture on Facebook until you get a red heart from me.

My Facebook picture is of a grey 5-star book award displayed as a picture saying Scott Chally for the name. So, if you see that grey looking symbol of a 5-star for your picture you will know you are one of the lucky ones to be selected. Your first and most important step you’ll be taking will let you to communicate with me. I’m asking if you are accepted by my liking of your picture for you to contact me. If you been accepted by the picture, I had liked with a red heart, you then may locate my address and send me a letter.

Write only on one sheet of paper what you’re like, what you like to do for fun, a little history of your family, what schooling or academics you may have been known for, stuff of humor and excitement is what I’m looking for. Also, I would like to have two 3x5 pictures to remember and to go along with your letter so I can refer back to you if I find you acceptable of what I like. I would like a closeup full body shot to see the face and body in skimpy sexy clothing or bathing suit. Then have a picture taken of above the waist and up close to show a good facial and cleavage picture that I may find attractive. If I find your letter interesting and I love the way you look, I’ll use your contact number to give you a call to talk 30 minutes or up to one hour on the phone if I find that you’re interesting within three months of receiving your letter depending on the number of women who contact me.

So, if you have made it past the third step you will be about halfway there to be selected as a woman of great recognition and honor in the eyes of the world. Realize, the women that I will select must not have any baggage with them like already having kids, taken care of other family members or in a relationship or marriage. The women must be clear in speaking English and writing to where I can understand. Also, there shouldn’t be any deficiencies, diseases or medical conditions that may be considered as a burden. Must be fertile to be able to have children. I will overlook most pictures of women with tattoos, this is a turn off for me. If you use drugs like crystal meth, heroin, LSD any hard drug other than marijuana and cocaine, I will not accept you as a member of the Royal Family and if you had made it into the Royal Family, I will have you removed from the tree.

You don’t have to be famous, have college or have accomplished great deeds within the world. You can be a common person that is cheerful and has a loving heart is what I’m looking for. I will send you some money and directions of what you have to do and where to go. You will be traveling to my hometown to be checked out through a doctor’s office of my liking. Just because you’re in my town doesn’t mean you should visit me, that will be a no-no, where I’ll feel like I’m being stalked by you and may have negative results.

So, step one was you get selected from Facebook with a “heart” like. Step two, you wrote to me a letter with two 3x5 pictures. Step three, I will call and talk to you. Step four, if I feel or have felt a connection with you, I will send you a letter within a month with some money and directions on what to do next. You will have to go to a doctor’s office in my hometown and answer over a hundred questions asked by the doctor as truthfully and as honest as you can. Lab tests will be done with a full physical to be administered to you.

Step five, of the women who pass the medical and questions to my liking, I will have an investigation and a criminal background check done on each woman who makes it this far. Step six will be of all I feel are worthy to stand true to me after the medical and criminal background check is done. I will send out an invitation to the desired woman of my liking to show up at a certain location at a certain time. There will be 10 women invited at a time to show up to these locations that I address within the letters. It will be 4 hours on a Saturday afternoon where it will be of ten women, me and my wife to mingle or do activities. Just because you have made it this far doesn’t mean you’re a shoe in, me and my wife will discuss who we feel like having in our family tree to be connected for eternity or as future generations come forth.

Now you’re wondering if you have got accepted after the meet and greet. This is the last step and I’ll call it lucky number seven because if you get a golden ticket from me, that means I’m willing to accept you in the family tree as a lifelong partner where you will bear our future children for the world. The golden ticket will be documentation of our commencement to honor one another in the holy commitment of saying we are tied to each other through God’s plan for the people of future generations of the world. When you get this ticket, it will come in a wrapped box inside of another package and it will be your last step to do in the process of being selected as one of God’s special children to be selected by me.

You see this ticket will be about 4x8 inches and will be a raised gold pattern on the face of the ticket with a message of commencement, my full name, signature, and a fingerprint of the marriage ring finger on the left hand. What each woman that receives a ticket will have to do is sign the ticket and, in the box, there will be an ink pad where the ring finger’s fingerprint of the left hand will be needed to complete the commencement to me and God. After you have signed your new name, it will be of your first and last name that you are known for with a new last name of Chally added after the two other names you are known for making it a three-name identification. You will then also need to place your ring fingerprint on the selected spot within the golden ticket.

What I would like is a two-minute video or less of the one that has been selected to have the ceremony filmed with either solo, by yourself in the video or friends and family members to watch you open the present, sign and seal the ceremony with your fingerprint added. I’ll then want for you to have a picture of you holding the golden ticket in front of yourself and for you to send it to me by text where I will post it on my Facebook to let the world know who are of the 400 women that have been selected. The tickets will be numbered between 1 and 400 only so, for each woman that gets selected you will know by her ticket number what order they will fall within to become pregnant.

The women I choose must dedicate their life in honoring me and the world of future generations when they commit with accepting to me as being my lifelong companion. That means there will not be any other men in their lives for any of these women during their entire life of all who fills these shoes for being true to me and the world. If I find proven adultery from any woman with another man while being my secondary wife, I will have her removed from the tree and if she has had a child of mine, that child will be taken care of by one of the other secondary wives in the palace to grow up with all their other half-brothers and half-sisters. I don’t mind if all my women I choose has bisexual tendencies towards other women or of one another to fill the gap or hole in

one's heart amongst the other wives due to the fact, I won't be able to be with all 400 wives every day and I want them to have the feeling they are loved.

The palace where the women will be living at, will be located in Monticello, Iowa and will have to be erected before the New World Order goes into effect. It will consist of 400 individual 1,200 square foot apartments where each woman of the 400 will set up to their liking of their living quarters as they wish. So that means that I have got to have all the women to be accepted into the Royal Family Tree by that time. So that tells me that it will be in January 2026 when I'll have selected all 400 women. That's a time frame of 2 1/2 years to gather up all the women of my liking. If I'm known to the world and excepted as the Messiah by July 24, 2023. That would tell me that the New World Order should be completed and come into effect sometime around or on the 24th of January 2027.

I will stay in contact with all my women that are to live in the palace to make sure all are taken care of accordingly. These women do not have to be tied down only to the palace, they can spend time away and do other things like travel or visit friends and relatives throughout the year as they wish. I would like for them to spend at least six months out of the year in the palace. I would like the 400 women to live in the palace until all our children are out of college or school. Then they may choose to live anywhere in the world.

Now for the palace, it will be beautiful and luxurious for the women's desires. There will be three main structures under a large glass canopy that will look like a pyramid to allow a vast amount of living space under a roof. The structure on both sides will consist of 100 units, 25 units per floor, four stories tall under the pyramid canopy with a center structure two to three stories taller of 200 units. This will be 100 units facing on both sides towards the other complexes under the canopy of glass on all sides. There will be balconies and walkways around each of the 3 structures under the roof with stairs and elevators of easy accessibility. It will be climate controlled inside of the temple where it will keep it cool during the summer and warm during the winter. I'm guessing that the temple will consist of a building foundation of 666-foot x 666-foot for the base of the glass pyramid structure to be made.

Understand that the space that is between the buildings within the roof of the pyramid will be filled with cement paving, botanical gardens, grass, palm trees, children's playgrounds, volleyball courts, tennis courts, saunas, Jacuzzi's, swimming pool, picnic areas, and whatever the women decide to have done for their home. They can change their living area to their liking as time goes on to fit them best.

There will be a choice the women will have to decide on when they start designing their quarters and that is seven choices from all the named brand chain restaurants in the states to choose to have in their temple. So, they will have at any time during the day and evening the choices of 7 different restaurants to choose from, like a steak house, Italian, Chinese, Mexican or of any fast food like McDonalds, or Taco Bell will be paid for by me or the people.

Of course, on the property there will be a workout center, track for running on, a golf course, a basketball courts, pickle ball, racquetball court, horse stables and plenty of acreage to motor bike or dune buggy on, with plenty of woods for my future family to hunt or have the accessibility to adventure within the land and be meant for the royal family to use.

There will be a ten-foot-high wall with lighting and wire on top constructed going all the way around the property with access gates of security guards and surveillance cameras. Only authorized people will be able to enter the premises from all of the different members from the Royal family that live on the Royal property. And I will have a mansion separately from the palace where nearby me and

my wife will live. There will be underground tunnels connecting the palace and other homes on the royal property. Realize I'm 52 years old at this time while I'm writing this New World Policy for the people and am willing to gift the world with my dependents. But I will not impregnate any woman before the New World Order is established for the people.

The date, I see for the New World Order to go into effect at this time is Sunday the 24th of January 2027. That means the first woman I had selected for my secondary wife will have the ability to become pregnant as early as Monday the 25th of January 2027. All the women will take their turn in the sequence order that I had selected them. They will have 6 days to spend with me in order to try to bear a child from me. Sundays or the 7th day I believe you're not supposed to work or cut your vineyards or plant your fields of that sort. So, I believe it's not good to try to conceive children on Sundays. Also, realize I will be 56 years old in 2027 and it will be 25 plus years since I knew I was fertile with my last child from my wife. So, I don't want to be tested for the world to know yes or no but wait until the time to see if the world is meant to have children from me as God's holy son. I may or will put some semen on ice for the future fertilization of women. I'll be about 63 years old by the time I rotate through all the women with granting each woman the quality time being with me.

After all the women have had their time with me, I will randomly go to and pick women from the palace who are willing to bear more children until I'm unable to conceive anymore children. The ages of the women I choose may be as early as 16 years of age and probably not older than 36 years of age. What I will say is I won't have sex with any woman under the age of 18 by the 25th of January 2027. So, if you fit this bracket try to post maybe you might be destined. Now you're thinking what if I'm sterile after all them years, well my back up plan will be for one or more of my 6 sons to step forward to handle the commitment to impregnate as many of the 400 women as possible. It could be through natural sex or artificial insemination by using of my son's specimen to impregnate the 400 women."

Reporter 3: "I heard a rumor that you would like to have multiple companions or partners for marriages. Is that true?"

Scott: "That is true! Not only will gays and lesbians be able to marry, but bisexuals who want multiple partners will also be able to marry as a combined relationship as well. You may say the Bible doesn't agree with this. But times are changing! All people will have fair rights to do as they wish. Even in the Bible it speaks of concubines in a relationship. I stand firmly behind this! Next question!"

Reporter 4: "What day are you looking at or when do you think the New World Order will be established for the world?"

Scott: "I foresee according to the Bible what I figured out that July 24, 2023, will be the day when the entire world will be united as one. Across the world, military arsenals will be done away with. There will no longer be any wars in the future. We will have and live in peace for the next thousand years. When we're successful or our final judgment day should be January 24, 2027, for the world to be changed. That'll be it for questions today. Thanks for coming!"

China's Dignitary: "Welcome, Scott, or should I say, Messiah?"

Scott: "Thank you, but really, I go by Scott!"

China's Dignitary: "Our house committee and the people of our country have been looking at your policy for a New World Order. Everybody seems to be enthused about it in our country. I like what the New World Order says for the people of the world. I'm scared about losing our military arsenal though. It would leave us defenseless as a country."

Scott: "I realize that, but that's what's going to make this as a success for the new world."

China's Dignitary: "What can you offer me to convince me today that there will be no more wars in the future?"

Scott: "I believe the United States has the most sophisticated military in the world. By July 24, 2023, would be the timeline when all the nations will have signed a contract for the world to discontinue their military forces. The US military will be one of the first to dismantle their military to show that the military will not be needed in the world to fight wars anymore. Would you stand beside the United States and dismantle your military at the same time? That's what I ask you here today."

China's Dignitary: "Yes, I will sign the contract to dismantle our military starting July 24, 2023, if you have 60 percent of all the countries in the world to dismantle their militaries at the same time."

Scott: "Thanks! I believe we have come to an agreement. It will actually be 100 percent of the militaries in the world that will need to agree. With you standing up for what I ask will prove it to the other countries that military is not needed in this world. There will be no more wars in the future."

China's Dignitary: "I would like to keep a few soldiers around though."

Scott: "You can keep a small crew of soldiers displaced in different districts across your country. There will be a total of 210,000 local soldiers from each of the 42 or more locations around the world to be as foot soldiers with the necessity of supplies to be able to move mobile to act on any situation that may arise for the people of the world. These soldiers or troops will not have weapons to use, just for humanitarian needs. They can be used for national disasters or riots.

There will be up to 5,000 troops located next to major populations around the world consisting of 42 or more different locations. This will be of Ace Services World Policy to allow up to .01% or of 700,000 soldiers, troops, considering the population of the world. There will be a total of 14 establishments of military bases across the 7 continents of the world and these bases will be all man or woman powered for the arsenal of military equipment.

Only the most sophisticated and advanced military equipment will be kept for training by these soldiers of the world. Each military core of the 14 locations around the world will consist of 35 thousand soldiers. Within the core, there will be four divisions broken up into air, water, sea and land.

Each Land Division will be of about 20 thousand soldiers to operate tanks, artillery, rockets, tow missiles, infantry, etc. within three locations in close vicinity of whatever continent it may be located in. The Army and Marines will be of the same force.

The Air Division will consist of 5,000 soldiers to maintain and operate planes, jets within the Air Force and will be of four installations or bases within each continent.

The Water Division will consist of 5,000 soldiers to be floating on the waters of the world on boats and ships. The Coast Guard will be absorbed in the water division of the Navy. There will only be two ports per water division around the world.

Per Sea Division will only be of underwater submarines and will consist of 5,000 soldiers to perform the duties of training. There will have to be a name made up for this Core of divisions. There will also only be one port per sea division.

This will equal out to just under 500 thousand soldiers to man the military arsenals around the world. There will be six times of mirrored or the exact military equipment stored evenly amongst the 14 core locations around the world to be maintained by the soldiers. We won't be having anymore wars amongst the countries of the world.

We don't know anything about extraterrestrials from other locations within the universe. So, we will keep a small force just in case we ever endure a war with an extraterrestrial life form. All nuclear weapons will be dismantled and prohibited for use across all the world."

China's Dignitary: "That's great and all! I'm happy for this, but I do have a question to ask you about immigration. How would we control our borders from other people entering and the people of our country exiting?"

Scott: "That's a good question. There shouldn't be much need for the people to move around in the world. They will be content to live in their own country. If they do choose to move, that is up to them individually to make that decision. All countries in the world will allow immigration to happen freely as the people wish.

All they would have to do is a change of address at the Ace Services office to where they would then live. They then will get paid the cost-of-living allowance for that district, county of that country where they would then live. Remember one thing in this new world that we're coming into soon. There will be unlimited amount of money to fix streets, build new schools, and anything that has to do with the public or the safety of the public. There will be multiple buildings of Ace Services for each district to assist the public. So, immigration is no longer a burden for where you have to wait for years sometimes decades to be able to relocate."

China's Dignitary: "What is going to be the universal language of the world? Is it going to be English?"

Scott: "It will be a requirement of the world for all schools to learn English as a primary language. If the individual country wants to adapt the language English as the common language, that is to be decided by the people of said country."

China's Dignitary: "What about all the money the United States owes us and other countries debt?"

Scott: "When the New World Order is launched on January 24th 2027 it will pay all the world's debt at that time. Each country then will pay whoever they may owe within 45 days to clear all government debt. Then Ace Services and everything with all people will be working on the new system. Currency around the world will all be the same for all the people to use as they like. Cash registers or cash drawers will have to be allowed for all the people.

If a licensed business is selling anything to the public, I will list what all the currency will consist of, starting with the 500-dollar bill where I'll place a picture of my oldest son, Stevie Ace Chally, on it. Next will be the 100-dollar bill where I will place a picture of my next oldest son, Alexander Von Chally, on it. The next bill will be the 50-dollar bill where I will place a picture of my next oldest boy, Nickolas Joe Chally, on it. The next bill will be the 20-dollar bill where I'll place a picture of my next oldest boy, Christian Lee Chally, on it. The next bill will be the 10-dollar bill where I'll place a picture of my next oldest boy, Janik Del Chally, on it. The next bill will be the 5-dollar bill where I will place a picture of my daughter, Vanessa Maria Chally, on it. The 2-dollar

bill will be of me, Scott LeRoy Chally, where there will be a picture. And the last bill will be of the 1- dollar and will show a picture of my youngest son, Dominik Roy Chally.

Coins for the world will be as follows: 1 dollar coin, 50 cent coin, 25 cent coin or quarter, 10 cent coin or dime, the nickel or five cents and the penny or one cent. Every seven years, five of the six coins will have a new person displayed on them that holds seat from the royal family of the world council. This will be of his or her sculpted picture image on the coin. The dollar coin will always display the image of me to the people to use or collect throughout the years.”
